

POISON SIGNS (Symptoms)

Parathion is a very dangerous poison. It rapidly enters the body on contact with all skin surfaces and eyes. Clothing wet with this material must be removed immediately. Exposed persons must receive prompt medical treatment or they may die.

Some of the signs and symptoms of poisoning are: Headache, nausea, vomiting, cramps, weakness, blurred vision, pinpoint pupils, tightness in chest, labored breathing, nervousness, sweating, watering of eyes, drooling or frothing of mouth and nose, muscle spasms and coma.

FIRST AID TREATMENT

Call a doctor (physician), clinic or hospital immediately. Explain that the victim has been exposed to parathion and describe his condition.

If breathing has stopped, start artificial respiratoin immediately and maintain unil doctor sees victim If swallowed and victim is awake (conscious) make him vomit guickly. Induce vomiting by sticking finger down throat or by giving soapy or strong salty water to drink. Repeat until vomit is clear Never give anything by mouth to an unconscious person. Have victim lie down and keep quiet. See doctor immediately.

In case of contact, immediately flush eyes or skin with plenty of water for at least 15 minutes while removing contaminated clothing and shoes. See doctor immediately.

NOTE TO PHYSICIAN

Antidote-administer atropine sulfate in large doses, TWO to FOUR mg. intravenously or intramuscularly as soon as cyan⁴ osis is overcome. Repeat at 5 to 10 minute intervals until signs of atropinization appear. 2-PAM chloride is also antidotal and may be administered in conjunction with atropine. DO NOT GIVE MORPHINE OR TRANQUILIZERS. Parathion is a strong cholinesterase inhibitor affecting the central and peripheral nervous systems and producing cardiac and respiratory depression. At first sign of pulmonary edma, the patient should be given supplemental oxygen and treated symptomatically. Continued absorption of the poison may occur and fatal relapses have been reported after initial improvement: VERY CLOSE SUPERVISION OF THE PAT-IENT IS INDICATED FOR AT LEAST 48 HOURS.



- DIRECTIONS FOR USE -

PROKIL PARATHION-4 is an emulsifiable concentrate containing 4 pounds parathion per gallon, for use in the control of certain insects and mites as specified. This product is for use only by thoroughly trained operators familiar with the handling of hazardous insecticides and is to be applied only by power sprayer or by aircraft. When applied use sufficient water for good coverage (3-10 gals, per acre by Aircraft--6-100 gals, by ground equipment). READ ENTIRE LABEL. Use strictly in accordance with dangers, cautions, warnings and directions, and with applicable State and Federal regulations Timing and dosage vary greatly between districts, as a consequence of loca! weather or conditions. Always follow the recommendations of State Agricul-

tural Extension Service concerning specific usage.

- BEANS: Aphids, Fleabeetles Armyworms (up to 3rd instar), Leathoppers, Red spider mites, Thrips—Apply 11/4 pints per acre in sufficient water to cover DO NOT apply within 15 days of harvest.
- BEETS: Fleabeetles, Armyworms (up to 3rd instar), Aphids, Red spider mites -Apply 11/4 pints per acre in sufficient water to cover. DO NOT apply within 15 days of harvest or 21 days if tops are to be used for food or feed
- BROCCOLI: Aphids, Fleabeetles, Cucumber beetles, Armyworms (up to 3rd instar), Loopers (immature)—Apply 1 pint per acre in sufficient water to cover. DO NOT APPLY within 7 days of harvest.
- **CABBAGE:** Fleabeetles, Armyworms (up to 3rd instar), Loopers (immature), Thrips, Aphids—Apply 1 pint per acre in sufficient water to cover DO NOT apply within 10 days of harvest.
- CARROTS: Aphids-Apply 112 to 2 pints per acre in sufficient water to cover DO NOT apply within 15 days of harvest. Do not use treated tops for food or teea
- COTTON: Stirk bugs. Leathoppers, Red spider mites-Apply 1 to 2 pints per acre in sufficient water to cover DO NOT apply wihthr. 5 days of hand picking Workers entering fields within 24 hours should wear protective clothing
- CUCUMBERS: Fleabeetles, Cucumber Beetles, Leatminers, Aphids-Apply a pint per acre in sufficient water to cover. DO NOT apply within 15 days of harvest DO NOT apply before vining
- GRASS: Armyworms Aphids -- Apply 1 : 6 pints in sufficient water to cover. Do not apply within 15 days of harvest or grazing
- LETTUCE (head): Aphids, Loopers (immature), Armyworms up to 3rd instar Leafminers-Apply i pint per acre in sufficient water to rover DO NOT aprly within 7 days of harvest.
- SQUASH (winter & summer): Fleabeetles, Arnite Leatminera-Apply 1 pint per acre in water sufficient to rover. DO NOT apply within 15 days d harvest.
- STRAWBERRIES: Lygus bugs, Red spider mites, Leatrollers-Apply I pint per acre in sufficient water to cover. DONOT apply within 14 days of harvest

PROKIL PARATHION-4 IS COMPATIBLE WITH THE FOLLOWING Pyrethrum Perthane, Toxaphene, Thiodon, Kelthane, Malathion, Guthion; Phosdrin Dibrom, Phosphamidon, Dylox.

DANGER: Keep all persons out of the operating area or vicinity where there may be danger of drift.
