
The Agency is conditionally approving the subject labeling amendment to the registration of the above-referenced product. This label amendment revises the current directions for use on potatoes as approved by the Agency in our letter of May 5, 1993. During the period that this amendment is effective, it will be subject to the same conditions cited in the Agency's letter of May 5, 1993.

This conditional registration for use on potatoes will expire automatically on September 30, 1995. Sale and distribution of the subject product bearing labeling for use on potatoes after September 30, 1995, will be illegal. The tolerance authorizing residues of the subject product in potatoes will expire automatically on May 5, 1996.

Submit two (2) copies of your final printed labeling before you release the product for shipment bearing the subject amended labeling.

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA section 6(e). Your release for shipment of the product constitutes acceptance of these conditions.

As explained in our letter of May 5, 1993, if the Agency finds that the required data are acceptable, EPA will consider an application to amend the registration of the subject product to allow use on potatoes without any special time restriction on the duration of the amendment should it receive such application.
