Required clothing and equipment for application:
All applicators, including homeowners, flaggers, and all personnel involved with the mixing, loading and transferring operations must wear the protective clothing and equipment enumerated below. Pilots are exempt from this requirement. The protective clothing and equipment to be worn is as follows:

- Impermeable gloves (rubber or plastic covered reinforced)
- Boots or boot covers
- long sleeve shirt and long pants
- wide brimmed hats

APPLY PROKIL DIMETHOATE W-25 INSECTICIDE BY GROUND ONLY in sufficient amount of water to provide sufficient coverage. Conventional ground sprayers—Small fruit 20-200 gals. per acre. Tree crops—(mature) 40-600 gals. per acre. Concentrate Ground Sprayers—Small Fruits and Tree Crops (mature)—30-40 gals. per acre.

APPLES, PEARS - Aphids, Leafhoppers, Pear psylla, Mites (except rust mites): Apply 1-2 lbs. per 100 gals. water. Do Not apply within 28 days of harvest. Do not apply during the bloom period. (2-lbs. maximum)

GRAPES: For raisin and wine grapes and table and canning grapes grown in California. To control grape leafhopper and pacific spider mite—apply 6-8 lbs. per acre. DO NOT apply within 28 days of harvest. DO NOT apply to canning or table grapes after berries reach ¼ inch in diameter.
