Dear Ms. Smith,

The amendment referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), as amended, for voluntary cancellation of carrots is acceptable, providing the following label changes are made.

On page 1,

1. Add the common chemical name "Dicloran" to the active ingredient statement.
2. Remove the spanish statement following the signal word. This product is classified as a toxicity category 3.
3. Revise the "Environmental Hazards" section as follows:

This product is toxic to fish. Do not discharge effluent containing this product into lakes, streams, ponds, estuaries, oceans, or other waters unless in accordance with the requirements of a National Pollution Discharge Elimination System (NPDES) permit and the permitting authority has been notified in writing prior to discharge. Do not discharge effluent containing this product to sewer systems without previously notifying the local sewage treatment plant authority. For guidance contact your State Water Board or Regional Office of the EPA. Do not contaminate water when disposing of equipment washwater or rinsate.

4. Revise the "Directions for use/formulation use cites" as follows:

Only for formulation into a fungicide for

1) Pre-harvest uses on apricots, beans (snap), celery, cherries (sweet), cucumbers, endive (escarole), garlic, grapes, lettuce (head and leaf), nectarines, onions, peaches, plums (fresh

prunes), potatoes, rhubarb, tomatoes, and ornamentals. Postharvest uses include sweet potatoes.

On page 2,

5. Replace the heading "Container Disposal" with "Container Handling".
6. Within the "Notice of Conditions of Sale and Warranty" section, in the second paragraph, first sentence, replace "Our recommendations" with "The directions".
