- 1) Under <u>Application Rates</u>, four additional spreader types (brands) were added to the table. There is no change in the rate nor the application instructions.
- 2) Under Weeds Controlled the common name "Hairy Crabgrass" has been changed to "Large Crabgrass".
- 3) The language on the advertising claim has been changed from "A selective herbicide with the preemergent applications intended for control of crabgrass and annual bluegrass in turfgrass." to "Granular Selective Herbicide with Preemergent Applications Intended to Control Crabgrass and Annual Bluegrass in Turf."
- 4) The signal word was incorrect in the Hazards to Humans and Domestic Animals section due to a typographical error. This has been corrected.
