Dear Ms. Baker:

The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act (FIFRA), as amended, is acceptable subject to the comments listed below. At your next label printing, or within eighteen (18) months, whichever comes first, you must incorporate this supplemental labeling into the main product labeling. A stamped copy of the label is enclosed for your records. Two (2) copies of the final printed label must be submitted prior to releasing the product for shipment.

1. You will comply with the data requirements specified on our letter to you dated March 28, 2006 (Amendment to Add Citrus, Grapes, and Pome Fruits; Reg. No. 10163-253 & 10163-277).
2. You will submit production information (pounds or gallons produced) for this product for the fiscal year in which the added uses are conditionally registered, in accordance with FIFRA Section 29. The fiscal year begins October 1 and ends September 30. The production information will be submitted to the Agency no later than November 15 following the end of the preceding fiscal year. 3. Make the following label changes:

- o Revise the application directions "*For applications by ground equipment ...*" to read "*Application by ground equipment only.*" Only ground application is approved for these uses.

You should note that if you fail to satisfy any of the conditions imposed on this registration, e.g., you fail to submit the required data by the specified deadlines or the data submitted were not generated in accordance with applicable test guidelines, EPA may issue notice to cancel these uses under FIFRA 6(e).
