The label amendment you submitted for the product referred to above is acceptable, provided that you do the following:

- 1. Change the active ingredient concentration from "96.0%" on the label to "98.4%." The purity of starting material has changed since registration of your product.
- 2. Replace the 2nd sentence "Do not discharge effluent identified in an NPDES permit" under ENVIRONMENTAL HAZARDS with "Do not discharge effluent containing this product into lakes, streams, ponds, estuaries, oceans, or other waters unless in accordance with the requirements of a National Pollutant Discharge Elimination System (NPDES) permit and the permitting authority has been notified in writing prior to discharge."
