Apply this product only through sprinkler, including center pivot, lateral move, end tow, side (wheel) roll, traveler, big gun, solid set or hand move; or drip (trickle), including surface an subsurface drip irrigation systems. Do not apply this product through any other type of irrigation system.

# SPRINKLER AND DRIP (TRICKLE) CHEMIGATION SYSTEMS

The system must contain a functional check valve, vacuum relief valve, and low pressure drain appropriately located on the irrigation pipeline to prevent water source contamination from backflow.

The pesticide injection pipeline must contain a functional, automatic, quick-closing check valve to prevent the flow of fluid back toward the injection pump.

The pesticide injection pipeline must also contain a functional, normally closed, solenoid-operated valve located on the intake side of the injection pump and connected to the system interlock to prevent fluid from being withdrawn from the supply tank when the irrigation system is either automatically or manually shut down.

The system must contain functional interlocking controls to automatically shut off the pesticide injection pump when the water pump motor stops, or in cases where there is no water pump, when the water pressure decreases to the point where pesticide distribution if adversely affected.

Systems must use a metering pump, such as a positive displacement injection pump (e.g., diaphragm pump) effectively designed and constructed of materials that are compatible with pesticides and capable of being fitted with a system interlock.

Do not apply when wind speed favors drift beyond the area intended for treatment.

To avoid injury application should be made at the beginning of the irrigation cycle, injecting over a 60-90 minute time period after all lines and sprinklers have been cleared and are operating correctly. Shut off injection equipment at the end of the application and continue to irrigate until a minimum of  $\frac{1}{2}$  -1 inch of water has been applied to the treatment area. Note: Injection equipment should be located as close to the pump as possible to ensure adequate mixing.
