### STATEMENTS OF PRACTICAL TREATMENT

- IF SWALLOWED:** Call a physician or Poison Control Center. Drink 1 or 2 glasses of water and induce vomiting by touching back of throat with finger. If person is unconscious, do not give anything by mouth and do not induce vomiting.
  - IF INHALED:** Remove victim to fresh air. If not breathing, give artificial respiration, preferably mouth-to-mouth. Get medical attention.
  - IF ON SKIN:** Wash with plenty of soap and water. Get medical attention if irritation persists.
  - IF IN EYES:** Wash with flowing water for at least 15 minutes.
  - SYMPTOMS OF POISONING:** A sense of "tightness" in the chest, sweating, contracted pupils, stomach pains, vomiting and diarrhea.
  - NOTE TO PHYSICIAN: ANTIDOTE -** Administer atropine sulfate in large therapeutic doses. Repeat as necessary to the point of tolerance. This compound inhibits cholinesterase resulting in stimulation of the central nervous system, the parasympathetic nervous system, and the somatic motor nerves. Do not give morphine. Watch for pulmonary edema, which may develop in serious cases of poisoning even after 12 hours. At first sign of pulmonary edema, the patient should be placed in an oxygen tent and treated symptomatically.

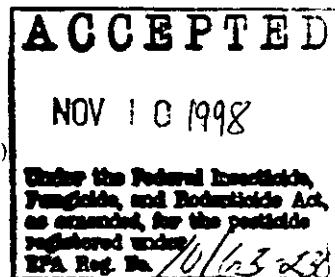
