**STATEMENTS OF PRACTICAL TREATMENT**

**N-Methyl Carbamate**

**IF SWALLOWED:** Vomiting should be induced. Administer water freely, and induce vomiting by giving one dose (½ oz. or 15 ml.) of syrup of ipecac. If vomiting does not occur within 10-20 minutes, administer second dose. If syrup of ipecac is not available, induce vomiting by sticking finger down throat. Repeat until vomit fluid is clear. Never give anything by mouth to an unconscious person. Professional medical assistance should be secured immediately. In case of poisoning, call a physician immediately. Have patient lie down and keep quiet.

**IF ON SKIN:** Remove contaminated clothing and wash skin immediately with soap and warm water.

**IF IN EYES:** Wash with flowing water for at least 15 minutes.

**SYMPTOMS OF POISONING:** A sense of "tightness" in the chest, sweating, contracted pupils, stomach pains, vomiting and diarrhea.

**NOTE TO PHYSICIAN:** Antidote—Administer atropine sulfate in large therapeutic doses. Repeat as necessary to the point of tolerance. Compound inhibits cholinesterase resulting in stimulation of the central nervous system, the parasympathetic nervous system and the somatic motor nerves. Do not give morphine. Watch for pulmonary edema, which may develop in serious cases of poisoning even after 12 hours. At first sign of pulmonary edema, the patient should be placed in an oxygen tent and treated symptomatically.
