The label referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act, as amended is acceptable provided you make the following changes:

Directions for Use - Application Directions:

In the second sentence after the "Compatibility" heading change "No Claim" to "No claim".

Directions for Use - Turf Uses:

- Change the first sentence from "Not for homeowner use." to "Not for homeowner use on turf."
- In the sentence in the "Crop" column of the application rate table, change "golf course greens, tees and fairways" to "golf course greens, tees, aprons and fairways".
- In the "Fusarium blight" entry in the "Disease" column of the application rate table, change "trticum" to "tricinctum".
- In the "Gray Leaf Spot" entry in the "Comments" column of the application rate table, change "w ith" to "with".
- Take the "Residential and public areas", "Tees/green/aprons" and "Fairways" bullets and text out of the "Turf Uses" table and place them under the new heading "Residential and Public Area Restrictions and Golf Course Restrictions".
- Change the headings "Tees/green/aprons" and "Fairways" to "Golf course tees/green/aprons" and Golf course fairways"

Directions for Use - Ornamental Uses:

- After the "Directions for use by homeowners" heading delete "For homeowner use on ornamentals only."
- Immediately before the sentence "Begin applications when weather conditions . . ." add the heading "Directions for All Users".
- In the "Diseases" column of the application rate table, correct the following disease names: "Fusiciadium" should be "Fusiciadium", "Fusrium" should be "Fusiciadium", "Mycrothecium" should be "Myrothecium", "Clylindrocladium" should be "Cylindrocladium" and "Pencillium" should be "Penicillium".

Storage and Disposal:

Change the heading "Storage" to "Pesticide Storage".

GENERAL CHEMIGATION USE INSTRUCTIONS

Apply this product only through sprinkler, including center pivot, lateral move, end tow, side (whee!) roll, traveler, big gun, solid set, or hand move, and drip irrigation systems. Do not apply this product through any other type of irrigation system.

Crop injury, lack of effectiveness, or illegal pesticide residues in the crop can result from non-uniform distribution of treated water.

If you have questions about calibration, you should contact State Extension Service Specialists, equipment manufacturers, or other experts.

CHEMIGATION SYSTEMS CONNECTED TO PUBLIC WATER SYSTEMS

Public water system means a system for the provision to the public of piped water for human consumption if such system has at least 15 service connections or regularly serves an average of at least 25 individuals daily at least 60 days out of the year.

Chemigation systems connected to public water systems must contain a functional, reduced-pressure zone, backflow preventer (RPZ), or the functional equivalent in the water supply line upstream from the point of pesticide introduction. As an option to the RPZ, the water from the public water system should be discharged into a reservoir tank prior to pesticide introduction. There shall be a complete physical break (air gap) between the outlet end of the fill pipe and the top or overflow rim of the reservoir tank of at least twice the inside diameter of the fill pipe. In addition, all directions and requirements specified for SPRINKLER OR DRIP CHEMIGATION SYSTEMS must be followed.

SPRINKLER OR DRIP CHEMIGATION SYSTEMS

The system must contain a functional check valve, vacuum relief valve, and low-pressure drain appropriately located on the irrigation pipeline to prevent water source contamination from backflow.

The pesticide injection pipeline must contain a functional, automatic, quick-closing check valve to prevent the flow of fluid back toward the injection pump.

The pesticide injection pipeline must also contain a functional, normally closed, solenoid-operated valve located on the intake side of the injection pump and connected to the system interlock to prevent fluid from being withdrawn from the supply tank when the irrigation system is either automatically or manually shut down.

The system must contain functional interlocking controls to automatically shut off the pesticide injection pump when the water pump motor stops, or in cases where there is no water pump, when the water pressure decreases to the point where pesticide distribution is adversely affected.

The irrigation line or water pump must include a functional pressure switch, which will stop the water pump motor when the water pressure decreases to the point where pesticide distribution is adversely affected.

Systems must use a metering pump, such as a positive displacement injection pump (e.g., diaphragm pump) effectively designed and constructed of materials that are compatible with pesticides and capable of being fitted with a system interlock.

Do not apply when wind speed favors drift beyond the area intended for treatment.

This product should be injected at the end of the irrigation cycle or as a separate application. Stop injection equipment after treatment is completed and continue to operate irrigation system until all of this product has been cleared from the last emitter.

Contact your local Gowan Company Representative or your State Agricultural Extension Service for advice on the prompt use of some other suitable fungicide.

OPERATING INSTRUCTIONS

Determine the acreage to be treated by the sprinkler system.

Measure the appropriate amount of Thiophanate-methyl 80 WDG needed to treat the acreage to be treated. Refer to specific directions for use for the application rate.

Add the pre-measured Thiophanate-methyl 80 WDG to the chemigation system supply tank and dilute with water if needed. Constant agitation is required to keep the product in solution when Thiophanate-methyl 80 WDG is used alone or tank mixed with other pesticides registered for sprinkler chemigation application.

Start the imigation system and bring the system up to full pressure, making certain that all sprinkler heads are functioning properly.

Engage the chemigation injection or venturi system to add the material to the irrigation lines.

Continue to run irrigation system for a few minutes after supply tank is empty to allow material in the irrigation lines to reach the sprinkler heads furthest from the chemigation injection point.

STORAGE AND DISPOSAL

DO NOT contaminate water, food or feed by storage or disposal.

STORAGE: Store product in original container only, away from other pesticides, fertilizers, food or feed.
