Dear Ms Smith:

The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act (FIFRA), as amended, is acceptable subject to the comments listed below. At your next label printing, or within eighteen (18) months, whichever comes first, you must incorporate this supplemental labeling into the main product labeling. A stamped copy of the label is enclosed for your records. Two (2) copies of the final printed label must be submitted prior to releasing the product for shipment.

1. You have previously agreed to submit the following generic data, required by the revised 40 CFR Part 158 rule that became effective on December 26, 2007. The data is due to the Agency by December 31, 2011:
 - o Acute and Subchronic neurotoxicity studies (Guideline 870.6200).
 - o Immunotoxicity study (Guideline 870.7800)

You should note that if you fail to satisfy any of the conditions imposed on this registration, e.g., you fail to submit the required data by the specified deadlines or the data submitted were not generated in accordance with applicable test guidelines, EPA may issue notice to cancel these uses under FIFRA 6(e).

Applications made by air to dense foliage may not provide adequate coverage of lower leaf surfaces for sufficient control. Use of higher labeled rates may be necessary.

RESTRICTIONS ON ALL CROPS

- Do not graze or feed livestock on cover crops growing in treated areas.
- Onager is an emulsifiable concentrate to be diluted with water for application in commercial plantings only.
- Apply Onager prior to adult mite build up. Onager will not control adult spider mites. Use higher rates on moderate to high mite infestations or for larger plants with a dense canopy. If adult mites are present in medium to high populations, better results may be obtained using Onager in combination with a registered contact adulticide. The use of less than label rates is not recommended with Onager.
- Do not make more than one application of Onager per year.
- Do not plant rotational crops other than those on this label within 120 days of this application.
