Gowan Company submits the enclosed revised label for Moncut 70-DF in order to fix a typographical error. The plant back restriction for soybeans was approved for 30 days and was added to the label however the word "soybeans" was not removed from the list of 240 day plant back crops. In support of this application, we have enclosed the following documents:

Notification of label change per PR Notice 2007-4. This notification is consistent with the guidance in PR Notice 2007-4 and the requirements of EPA's regulations at 40 CFR §§ 156.10, 156.140, 156.144, 156.146, and 156.156. No other changes have been made to the labeling or the Confidential Statement of Formula for the product. I understand that it is a violation of 18 U.S.C. AGRICULTURAL USE REQUIREMENTS

GENERAL INFORMATION

Moncut® 70-DF is a systemic fungicide for suppression of powdery scab, Spongospora subterranea, and control of black scurf, Rhizoctonia solani, in potatoes.

Moncut 70-DF is not for sale, sale into, distribution, and or use in Nassau and Suffolk counties of New York State.

MIXING INSTRUCTIONS

- Buffer the water in the spray tank.
- Fill the spray tank ¾ full. Turn on spray tank agitation. Pour recommended amount of this material on the surface of water in the spray tank.
- Add balance of water to spray tank.
- Keep agitation running during filling and spraying operations.

USE PRECAUTIONS

Do not use oil as carrier or add other additives to the finished spray.

Do not plant rotational crops other than peanuts, rice, or potatoes for 12 months following last application of Moncut 70-DF, with the following exceptions:

- Soybeans or wheat may be planted 30 days after the last application.
- Leafy vegetables (such as lettuce, spinach, or celery), or small grain crops other than wheat (such as barley, rye, or oats) may be planted 150 days after the last application.
- Corn (such as field, sweet, or popcorn), seybeans, sorghum, or cotton may be planted 240 days following the last application of Moncut 70-DF.

Mississippi County: Within the basin that drains directly into the Right Hand Chute of Little River, south of Big Lake National

Refuge.

Poinsett County: Between Crowley's Ridge and the levee east of the Right Hand Chute of Little River and the St. Francis Floodway. Use is also prohibited west of Rt. 140 and north of Rt. 63 at the SIPHON near Marked Tree, except that the prohibited area does not include the area bounded by Arkansas Highway 373 on the west, Highway 63 on the east, and Highway 14 on the south.

Cross, St. Francis, and Lee Counties: Between Crowley's Ridge and the levee east of the Right Hand Chute of Little River and the St. Francis Floodway as far south as the confluence of L'Anguille River (Lee County).
