- c. Revise the signal word under the "Keep Out of Reach of Children" statement to read "WARNING".
- d. Revise the Precautionary Statements to read as follows: "Causes substantial but temporary eye injury. Harmful if swallowed, inhaled or absorbed through the skin. Avoid breathing dust. Do not get in eyes or on clothing. Wear goggles, face shield, or safety glasses and protective clothing such as coveralls, a long-sleeved shirt, and pants. Wash thoroughly with soap and water after handling. Remove contaminated clothing and wash before reuse."
- e. Move the sentence "It is a violation of Federal law to use this product in a manner inconsistent with its labeling." so that it appears immediately below the heading "Directions for Use".
