### Weed Control in Seedling Alfalfa During Establishment

Treflan TR-10 may be applied as a preplant incorporated treatment for preemergence control of labeled weeds in seedling alfalfa. Apply and incorporate prior to planting according to product label directions.

**Broadcast Application Rates:** 

Soil Texture	Treflan TR-10 (pounds/acre)
Coarse	5.0
Medium	5.0 – 7.5*
Fine	7.5

<sup>\*</sup>Use lower rate in rate range in areas receiving less than 20 inches of rainfall and irrigation.

Precautions: Some crop stand reduction and stunting may occur with this use of Treflan TR-10, however, reduced weed completion will allow establishment of a quality stand.
