Sprinkler Irrigation Application

Apply AMBUSH Insecticide at rates and timing described elsewhere in this label. Apply with center pivot or continuous-move equipment distributing is acre-inch or less during treatment. If stationary (solid sets, handlines or wheel lines other than continuous-move) are used, AMBUSH insecticide should be injected into no more than the last 20-30 minutes of the set. Do not apply when winds are greater than 10-15 mph to avoid drifts or wind skips. Thorough coverage of foliage is required for good control. Good agitation should be maintained during the entire application period.

- A. Apply this product only through (sprinkler including center pivot, lateral move, end tow, side [wheel] roll, traveler, big gun, solid set, or hand move) irrigation system(s). Do not apply this product through any other type of irrigation system.
- B. Crop injury, lack of effectiveness, or illegal pesticide residues in the crop can result from nonuniform distribution of treated water.
- C. If you have questions about calibration, you should contact State Extension Service specialists, equipment manufacturers or other experts.
