NOTE TO PHYSICIAN OR VETERINARIAN: This product may reduce the clotting ability of the blood and cause hemorrhaging. If poisoning occurs, intramuscular and oral administration of Vitamin K₁ are indicated, as in poisoning from overdose of bishydroxy coumarin. For human cases, Vitamin K₁ is antidotal at doses of 10-20 mg (not mg/kg). For animal cases, Vitamin K₁ is antidotal at 2-5 mg/kg. Repeated doses may need to be given up to two weeks (based on monitoring of prothrombin times). In severe cases, blood transfusions may be necessary.
