Subject: Label Revisions - PR Notice 91-8 CYPERMETREIN Technical EPA Registration Number 10182-68 Your Letter Dated April 22, 1993

The amendment referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), is acceptable provided that you:

Revise the submitted labeling as described below:

1. The transportation vehicles uses on the submitted labeling is considered food/feed uses. The cargo areas of the vehicles may or may not be thoroughly cleaned after treatment. It is reasonable to assume that directions to clean the cargo areas after treatment to remove residual pesticides are not practical and either "could not or would not" be followed. It is likely that the cargo areas of cypermethrin treated boxcars, trucks, aircraft, ship and other transportation vehicles would bear residual residues of the insecticide. Food or feed transported in these conveyances after this treatment could become contaminated with residues of the cypermethrin insecticide. Thus following these sites, delete food/feed-empty and replace it with the qualifier "non-food/feed."

2. We also note the listing of other commercial sites without the appropriate qualifier "non-food/feed," i.e. Hotel/Motel, Tourist Coules, Boats, Ships; Eating Establishments, etc..; Commercial/Institutional/Industrial Building, etc.. You must add the non-food/feed qualifier to these sites.

3. PR-Notice 91-8 has been withdrawn and replaced with PR Notice 94-1. We suggest you review this latter notice for additional labeling comments.




