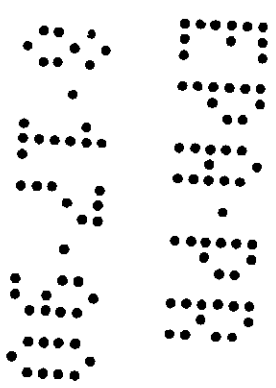

STATEMENT OF PRACTICAL TREATMENT

IF IN EYES: Immediately flush with plenty of water for at least 15 minutes. Call a physician if irritation persists.

IF SWALLOWED: Do not induce vomiting. Call a physician immediately.

IF ON SKIN: Wash with plenty of soap and water. Get medical attention if irritation persists.

IF INHALED: Remove to fresh air. If not breathing, give artificial respiration, preferably mouth-to-mouth. If breathing is difficult, give oxygen. Call a physician.

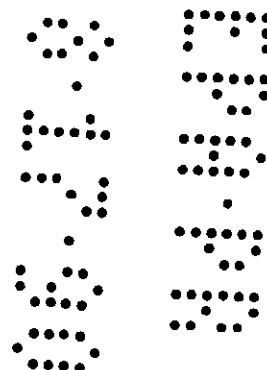
NOTE TO PHYSICIAN: Inducing vomiting as first aid for this substance may result in increased risk of chemical pneumonia or pulmonary edema caused by aspiration of the hydrocarbon solvent. Vomiting should be induced only under professional supervision.

Atropine is antidotal for cholinesterase inhibition. Give 2 mg. of atropine intramuscularly or subcutaneously and repeat if symptoms of poisoning reappear. Pralidoxime (2 PAM) may be given if available. Give 1 gram intramuscularly or intravenously and repeat as necessary.

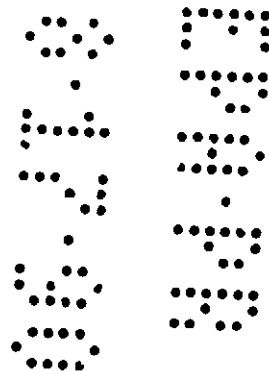

Apply the specific amount of ACTELLIC in 5 gallons of water to each 60,000 pounds of grain.

Apply spray solution uniformly with suitable applying equipment as grain enters storage or export container. Select nozzle size and operating pressure to adjust the application rate with the flow of grain. Apply the spray solution as a coarse, uniform, low pressure spray in order to minimize drift. Shield nozzle if necessary.

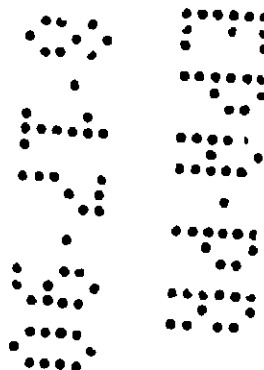

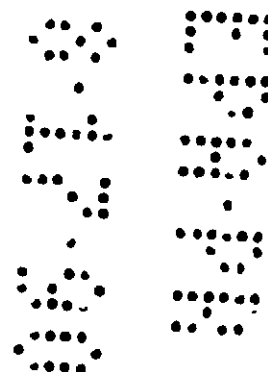




REMARKS AND PRECAUTIONS

ICI research has concluded that application rates of 0.55 to 0.75 pints of ACTELLIC 5E in 5 gallons of water per 30 tons (60,000 pounds) of wheat, corn, or grain sorghum (6-8 ppm) or 0.9 to 1.4 pints of ACTELLIC in 5 gallons of water per 30 tons of rice (9-15 ppm) are necessary for consistent and lasting control of insects. Application of rates less than the aforementioned may affect efficacy and may result in reduced length of control. Use at less than these rates shall be at the sole risk of the buyer and user.

Shipping documents accompanying ACTELLIC 5E treated commodities must state that the treated commodity is intended for export only and is not to be sold for use in the USA.





STORAGE AND DISPOSAL

Prohibitions: Do not contaminate water, food or feed by storage or disposal. Open dumping is prohibited. Do not reuse empty container.

Storage: Store in a cool place and protect from freezing. If accidentally frozen, reconstitute by gently warming to room temperature and thoroughly mixing contents. Keep container closed when not in use.

Pesticide Disposal: Pesticide wastes are toxic. Improper disposal of excess pesticide, spray mixture, or rinsate is a violation of federal law.
