HARMFUL IF SWALLOWED OR ABSORBED THROUGH SKIN. CAUSES EYE IRRITATION - DO NOT GET IN EYES, ON SKIN OR ON CLOTHING.

ENVIRONMENTAL HAZARDS: This product is extremely toxic to fish. Do not contaminate water by cleaning of equipment or disposal of wastes. Keep out of lakes, streams or ponds. Apply this product only as specified on this label. Care should be used when spraying to avoid fish and reptile pools.

### STORAGE AND DISPOSAL

PROHIBITIONS: Do not contaminate water, food or feed by storage or disposal. Do not reuse empty container.

STORAGE: Mix as needed. Do not store diluted material. Do not store near food or feed. In case of spill on floor or paved surfaces, sweep up and remove to chemical waste area. Keep water-soluble packets in original foil package and store in a cool dry place. Do not store below 32°F. Handle carefully when stored at temperatures less than 50°F to avoid breakage of packets.

PESTICIDE DISPOSAL: Wastes resulting from the use of this product may be disposed of on site or at an approved waste disposal facility.

CONTAINER DISPOSAL: When all packets are used dispose of foil package in a sanitary landfill or by incineration, or if allowed by state and local authorities, by burning. If burned stay out of smoke.

## DIRECTIONS FOR USE

It is a violation of federal law to use this product in a manner inconsistent with its labeling.

For residual pest control in and on buildings and structures and their immediate surroundings and on modes of transport. Permitted areas of use include, but are not limited to, stores, warehouses, industrial buildings, houses, apartment buildings, greenhouses, laboratories, and on vessels, rail cars, buses, trucks, trailers and aircraft. Also may be used in nonfood areas of schools, nursing homes, hospitals, restaurants, hotels and food manufacturing, processing and servicing establishments.

Do not allow packets to become wet before adding to the spray tank. Wear dry rubber gloves when handling packets. Minimize handling of packets since excessive handling may cause rupture.

DEMON WP insecticide is intended for dilution with water for spray application. Do not use strainers finer than 50 mesh size. Fill sprayer to 1/2 of the desired volume. Add water-soluble packet(s) of DEMON WP insecticide per the table below. Add remaining water needed and wait for 2 minutes for packet(s) to dissolve. Close and shake for 30 seconds before use. Shake again before use if spraying is interrupted. Make up only as required, repeat treatments when needed.

**Cockroaches, Spiders, Crickets, Silverfish and Firebrats:** Apply as a coarse, low pressure spray to areas where these pests hide, such as baseboards, corners, storage areas, closets, around water pipes, doors and windows, attics and eaves, behind and under refrigerators, cabinets, sinks, furnaces, and stoves, the underside of shelves, drawers and similar areas. Pay particular attention to cracks and crevices; also see OUTDOOR USE.

**Ants:** Apply to any trails, around doors and windows and other places where ants may be found. Apply barrier treatments to prevent infestation as described below; also see OUTDOOR USE.

**Wasps and Bees:** Thoroughly spray nest and entrance and surrounding areas where insects alight; also see OUTDOOR USE.

**Sowbugs, Pillbugs, Millipedes and Centipedes:** Apply around doors and windows and other places where these pests may be found or where they may enter premises. Spray baseboards, storage areas and other locations. Apply barrier treatments to prevent infestation as described below; also see OUTDOOR USE.

**Flies:** Apply directly to walls, ceilings, window screens and other fly resting areas as a residual surface treatment. May be used inside residential buildings as well as in and around carports, garages, and storage sheds; also see OUTDOOR USE.

**Food Handling Establishments:** Places other than private residences in which food is held, processed, prepared or served:

**Nonfood Areas:** DEMON WP insecticide may be used as a general spot or crack and crevice treatment in nonfood areas. All areas where insects hide or through which insects may enter should be treated.

**Food Areas:** DEMON WP is not labeled for use in food areas. Do not use in any area where food or feed is stored, prepared or consumed.

**Outdoor Use:** For control of ants, bees, centipedes, cockroaches, crickets, firebrats, millipedes, silverfish, sowbugs, pillbugs, spiders, flies and wasps. Apply as a residual spray to surfaces of buildings, porches, screens, window frames, eaves, patios, lawns, refuse dumps, garages in either hand or power sprayer and in other areas where these pests are found.

**Barrier Treatments:** To help prevent infestation of buildings, apply to a band of soil and vegetation 6 to 10 feet wide around and adjacent to the building. Also, treat the building foundation to a height of 2 to 3 feet where pests are active and may find entrance. Apply as a coarse spray to thoroughly and uniformly wet the band area, using 1 gallon of spray mix per 400 square feet.

Do not apply this product to edible crops.

**Caution:** Do not use water base sprays of DEMON in conduits, motor housings, junction boxes, switch boxes, or other electrical equipment because of possible shock hazard. Let surfaces dry before allowing children and pets to contact surfaces. Protect aquariums from spray mist. Thoroughly wash out sprayer and screen with water and detergent before using DEMON WP insecticide. Do not use this product with oil.
