

COCKROACHES, SPIDERS, CRICKETS, SCORPIONS, SILVERFISH, TICKS AND FIREBRATS:

Apply as a coarse, low pressure spray to areas where these pents hide, such as baseboards, comers, storage areas, closets, around water pipes, doors and windows, attics and eaves, behind and under refrigerators, cabinets, sinks, furnaces, and stoves, the underside of shelves, drawers and similar areas. Pay particular attention to cracks and crevices; also see CUTDOOR USC.

ANTS:

Apply to any trails, around doors and windows and similar areas where ants may be found. Apply barrier treatments to prevent infestation as described below; also see OUTDOOR USE.

Spray when pests first appear; retreat when needed. Delay watering or mowing the treated area for 12 to 24 hours after treatment. Use a minimum of five gallons spray mix per 1000 square feet when spraying.

FOOD HANDLING ESTABLISHMENTS:

Places other than private residences in which food is held, processed, prepared or served:

Nonfood Areas: DEMON WP insecticide may be used as a general spot or crack and crevice treatment in nonfood areas. Similar areas where insects hide or through which insects may enter should be treated.

Examples of nonfood areas include garbage rooms, lavatories, floor drains (to sewers), entries and vestibules, offices, locker rooms, machine rooms, boiler rooms, garages, mop closets and storage (after canning or bottling).

Apply as a residual spray to surfaces of buildings, porches, screens, window frames, eaves, patios, lawns, refuse dumps, garages by either hand or power sprayer and in similar areas where these pests are found.

BARRIER TREATMENT (except cockroaches):

To help prevent infestation of buildings, apply to a band of soil and vegetation 6 to 10 feet wide around and adjacent to the building. Also, treat the building foundation to a height of 2 to 3 feet where pests are active and may find entrance. Apply as a coarse spray to thoroughly and uniformly wet the band area, using 1 gallon of spray mix per 400 square feet.
