



#### **STATEMENT OF PRACTICAL TREATMENT**

IF IN EYES: Flush eyes with plenty of water. Call physician if irritation persists.

IF ON SKIN: Wash with plenty of soap and water. Get medical attention if irritation persists.

PHYSICAL OR CHEMICAL HAZARDS: Do not use or store near heat or open flame.

#### STORAGE AND DISPOSAL

**PROHIBITIONS:** Do not contaminate water, food or feed by storage or disposal. Open dumping is prohibited. Do not reuse empty container.

**STORAGE:** Store in original container only. Keep container closed when not in use. Do not store near food or feed. In case of spill or leak on floor or paved surfaces, scakup with sand, earth or synthetic absorbent.

PESTICIDE DISPOSAL: Pesticide wastes are toxic, improper disposal of excess pesticide, spray mixture or rinsate is a violation of Federal law. If these wastes cannot be disposed of by use according to label instructions, contact your State Pesticide or Environmental Control Agency or the Hazardous Waste Representative at the nearest EFA Regional Office for guidance.

### CONTAINER DISPOSAL:

Metal Containers: Triple-rinse (or equivalent). Then offer for recycling or reconditioning, or puncture and dispose of in a sanitary fandfill or by other procedures approved by state and local authorities.

Plastic Containers: Triple-rinse (or equivalent). Then offer for recycling or reconditioning, or puncture and dispose of in a sanitary landfill, by incineration, or if allowed by state and local authorities, by burning. If burned, stay out of smoke.

Glass Containers: Triple-rinse (or equivalent). Then dispose of in a sanitary landfill or by other approved state and local procedures.
