

Plants: Apply directly to walls, ceilings, under areas in a residual surface treatment of buildings or not as in and around airports, etc. see OUTDOOR USE

Food Handling, Eating/Drinking: Residual areas in which food is held, processed, prepared or served: DEMON EC must be applied to crack and crevice treatment in cracks, holes or through which insects (in sewers), drains and ventholes, offices, boiler rooms, garbage-room chutes and areas.

Food Areas: DEMON EC is not labeled for use in food areas of food processing plants, food is commonly prepared or processed. Food is served such as dining rooms, etc. Food is prepared or held in the form of food would be served during treatment or. Exposed food should be covered or removed areas for receiving, storage, packing, processing, etc. with water. DEMON EC is not labeled for use in food areas of food processing plants.

Outdoor Use: For control of cockroaches, spiders, silverfish, etc. in cracks, holes, pipes, valves, drains, garages, and in other areas where these pests are found.

STORAGE AND DISPOSAL

Cockroaches, Spiders, Crickets, Silverfish and Firebrats: Apply as a narrow low pressure spray to areas where these pests hide, such as baseboards, corners, storage areas, drains, around water pipes, doors and windows, attics and eaves, behind and under refrigerators, cabinets, sinks, furnaces and stoves, the underside of shelves, drawers and under seats. Pay particular attention to cracks and crevices. Also see OUTDOOR USE.

Ants: Apply to any trails, around doors and windows and other places where ants may be found. Refer to barrier treatment directions to prevent infestation. Also see OUTDOOR USE.

Wasp and Bees: Application to nests should be made late in evening when insects are all near. Thoroughly spray nest and entrance and surrounding areas where insects alight. Also see OUTDOOR USE. **Beetles, Pillbugs, Silverfish and Carpenter:** Apply around doors and windows and other places where these pests may be found or where they may enter premises. Spray baseboards, storage areas and other locations. Refer to barrier treatment directions to prevent infestation. Also see OUTDOOR USE.
