The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, is acceptable provided that you make the labeling changes indicated below prior to release for shipment of product bearing the amended labeling:

1. We have completed review of the submitted six acute toxicity studies (MRID's 430139-01 through 430139-06). The acute toxicity profile for your product is as follows:

Based on this acute toxicity profile we have the following labeling comments for the Precautionary Statements and Statement of Practical Treatment:

The precautionary statements must state:

"May be fatal if swallowed. Causes skin irritation. Harmful if inhaled or absorbed through skin. Causes moderate eye irritation. Do not get on skin or clothing. Avoid contact with eyes. Avoid breathing vapor or spray mist. Wash thoroughly with soap and water after handling. Remove and wash contaminated clothing before reuse." (You may retain statements regarding protective clothing).

The statements of practical treatment should state:

IF SWALLOWED: Call a physician or Poison Control Center. Drink 1 or 2 glasses of water and induce vomiting by touching the back of throat with finger. Do not induce vomiting in or give anything by mouth to an unconscious person.

IF ON SKIN: Wash with plenty of soap and water. Get medical attention.

IF IN EYES: Flush with plenty of water. Call a physician if irritation persists.

IF INHALED: Remove victim to fresh air. If not breathing, give artificial respiration, preferably mouth-to-mouth. Get medical attention.

- 2. California Department of Pesticide Regulation (CDPR) reviewed all studies except the dermal sensitization. CDPR placed the study into toxicity category III, however Precautionary Review Section (PRS) has placed the study into category II. This discrepancy in toxicity categories may be due to a slight difference in the terminology used in the report's Draize Scale when compared to other references for the Draize Scale.
- 3. The dermal sensitization study is unacceptable and must be reconducted. Please refer to the enclosed review for more information. Once an acceptable study is submitted we may require additional labeling statements.
- 4. Replace the precaution, "Do not use in greenhouses where crops for food or feed are grown" with "Do not use in commercial greenhouses or nurseries. Not for use on plants being grown for sale of other commercial use, or for commercial seed production, or for research purposes. Do not use in on food or feed crops."
- 5. Please confirm that the Confidential Statement of Formulation dated April 30, 1992, is the basic formula of record. The acute toicity studies used to support this product were conducted using this formulation.

Submit three copies of your final printed labeling before you release the product for shipment. A stamped copy of the labeling is enclosed for your records.

PROHIBITIONS: Do not contaminate water, food or feed by storage or disposal. Open dumping is prohibited. Do not reuse empty container.

COCKROACHES, SPIDERS, CRICKETS, SCORPIONS, SILVERFISH, TICKS AND FIREBRATS:

Apply as a coarse, low pressure spray to areas where these pests hide, such as baseboards, corners, storage areas, closets, around water pipes, doors and windows, attics and eaves, behind and under refrigerators, cabinets, sinks, furnaces, and stoves, the underside of shelves, drawers and similar areas. Pay particular attention to cracks and crevices; also see **OUTDOOR USE**.

ANTS:

Apply to any trails, around doors and windows and similar areas where ants may be found. Refer to barrier treatment directions to prevent infestation; also see **OUTDOOR USE**.

WASPS AND BEES:

Application to nests should be made late in evening when insects are at rest. Thoroughly spray nest and entrance and surrounding areas where insects alight; also see **OUTDOOR USE**.

BOXELDER BUGS, SOWBUGS, PILLBUGS, MILLIPEDES, ELM LEAF BEETLE AND CENTIPEDES:

Apply around doors and windows and similar areas where these pests may be found or where they may enter premises. Spray baseboards, storage areas and other locations. Refer to barrier treatment directions to prevent infestation; also see **OUTDOOR USE**.

BEES FLIES MOSQUITOS AND WASPS:

Apply directly to walls, ceilings, window screens, and other fly resting areas as a residual surface treatment. May be used inside residential buildings as well as in and around carports, garages, and storage sheds; also see **OUTDOOR USE**.

SCORPIONS:

Treat and remove accumulations of lumber, firewood, and other materials which serve as harborage sites. Apply as a coarse spray to the point of drip; also see **OUTDOOR USE**.

CONTROL OF WOOD INFESTING BEETLES:

To control wood infesting insects such as powderpost beetle (Lyctidae), false powderpost beetles (*Bostrichidae*), deathwatch beetles (*Anobiidae*), old house borers (*Cerambycidae*) and ambrosia beetles (*Scolytidae*) in homes and other structures, apply as an emulsion containing 0.2% DEMON EC. For treatment of small areas, apply by brushing the emulsion evenly on wood surfaces. For large or overhead areas, apply as a coarse spray to the point of runoff. When spraying overhead interior areas of homes, apartment buildings, etc. spray to the point of runoff, cover all surfaces below the area being sprayed with plastic sheeting or other material which could be disposed of by placing in trash if contamination from dripping occurs. Sprayed surfaces should be avoided until spray has totally dried. Do not use in structures occupied by animals to be used for food purposes or which produce products for human consumption.

FOOD HANDLING ESTABLISHMENTS:

Places other than private residences in which food is held, processed, prepared or served:

Nonfood Areas: DEMON EC insecticide may be used as a general, spot or crack and crevice treatment in nonfood areas. Similar areas where insects hide or through which insects may enter should be treated.

Examples of nonfood areas include garbage rooms, lavatories, floor drains (to sewers), entries and vestibules, offices, locker rooms, machine rooms, boiler rooms, garages, mop closets and storage (after canning or bottling).

Food Areas: DEMON EC is not labeled for use in food areas. Do not use in food areas of food handling establishments, restaurants or other areas where food is commercially prepared or processed. Do not use in serving areas while food is exposed or facility is in operation. Serving areas are areas where prepared foods are served such as dining rooms but excluding areas where foods may be prepared or held. In the home all food processing surfaces and utensils should be covered during treatment or thoroughly washed before use. Exposed food should be covered or removed.

Examples of food areas are areas for receiving, storage, packing (canning, bottling, wrapping, boxing), preparing, edible waste storage and enclosed processing systems (mills, dairies, edible oils, syrups). Serving areas (when food is exposed and facility is in operation) also would be considered a food area.

OUTDOOR USE

For control of ants, bees, centipedes, cockroaches, crickets, earwigs, fleas, millipedes, mosquitoes, scorpions, sowbugs, pillbugs, spiders, ticks, flies and wasps. Apply as a residual spray to surfaces of buildings, porches, screens, window frames, eaves, patios, lawns, refuse dumps, garages by either hand or power sprayer and in similar areas where these pests are found.

BARRIER TREATMENT (except cockroaches):

To help prevent infestation of buildings, apply to a band of soil and vegetation 6 to 10 feet wide around and adjacent to the building. Also, treat the building foundation to a height of 2 to 3 feet where pests are active and may find entrance. Apply as a coarse spray to thoroughly and uniformly wet the band area, using 1 gallon of spray mix per 400-1000 square feet.

TREATMENT OF PRECONSTRUCTION LUMBER AND LOGS

To protect unseasoned lumber and logs from wood destroying insects, such as Termites, Carpenter Ants and Beetles (Ambrosia, Powder-post, Old house borers and others), totally treat wood with a 0.25% to 0.5% solution of DEMON EC. This solution can be applied by various methods including spraying, brushing, dipping, and pressure treatment. Frequent monitoring of dip and pressure systems are necessary to insure that the desired level of DEMON EC is maintained. Wood can be handled after treatment when dry.

- 1. For dip treatments, the wood should be totally submersed in the solution until thoroughly wet and then allowed to dry in a suitable location. Dipping solutions to which DEMON EC has been added should be agitated before use if left unused for long periods of time. Sediment, debris and other deposits should be periodically cleaned from the tank.
- For pressure treatments, the wood should be placed in the treatment chamber, the DEMON EC solution added and the system pressurized up to 250 psi for up to one hour depending on the density and type of wood treated. After the pressure is released and the system drained, the wood should be placed in a suitable location for drying.
- 3. For spray treatments, the wood should be sprayed thoroughly including back and ends.
- 4. For brush treatments, all parts of wood surfaces should be thoroughly treated.

NOTE: Do not use water base sprays of DEMON EC in conduits, motor housings, junction boxes, switch boxes, or other electrical equipment because of possible shock hazard. Let surfaces dry before allowing children and pets to contact surfaces. Protect aquariums from spray mist. For best results, thoroughly wash out sprayer and screen with water and detergent before using DEMON EC insecticide. Do not use this product with oil.

Do not apply this product to edible crops.

During any application to overhead interior areas of structure, cover surface below with plastic shielding or similar material.
