

ORDRAM 10-G should be applied to murky (silty) water after working of soil. APPLICATION: Apply ORDRAM 10-G into the flood water by air application. Follow with seeding 2-3 days after the ORDRAM 10-G application. RATE: Apply 30 pounds of ORDRAM 10-G per acre.
