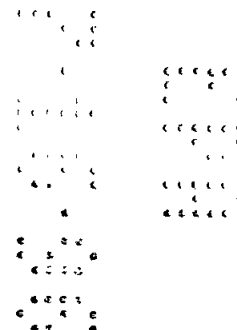

STATEMENT OF PRACTICAL TREATMENT

FIRST AID: Immediately start the procedures given below and CONTACT A POISON CENTER, A PHYSICIAN, OR THE NEAREST HOSPITAL.
