The labeling cited above and submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), as amended, is accepted subject to the comments reflected on the enclosed sheet. A copy of your proposed labeling stamped "ACCEPTED WITH COMMENTS" is enclosed.

**WHAT THIS ACCEPTANCE MEANS:**

Based on your certification, the Agency has accepted the labeling changes that are necessary to comply with the Worker Protection Standard (WPS) labeling requirements of 40 CFR part 156, subpart K, described in PR Notices 93-7 and 93-11. Any other labeling changes submitted in connection with this amendment application but not directly related to compliance with the WPS have not been reviewed or accepted by the Agency. If you wish to make such changes, you must submit a separate amendment application proposing them. If your product is currently suspended, the acceptance of this labeling amendment does not affect the suspension in any way.

- WITHIN one year from date of this acceptance.





### STATEMENT OF PRACTICAL TREATMENT

Immediately start the procedures given below and contact a Poison Center, a physician, or the nearest hospital. Report the type and extent of exposure, describe the victim's symptoms and follow the advice given.

**IF SWALLOWED:** Immediately give several glasses of water and induce vomiting by gagging the victim with a finger placed on the back of the victim's tongue. Give fluids until vomitus is clear. Do not induce vomiting or give anything by mouth to an unconscious or convulsing person.

**IF ON SKIN:** Flush all affected areas with plenty of water for several minutes. Remove and clean contaminated clothing and shoes. Seek medical attention if skin irritation occurs.

**IF IN EYES:** Immediately flush eyes with large amounts of running water for 15 minutes. Hold eyelids apart to ensure rinsing of the entire surface of the eye and lids and water. Get medical attention immediately.
