DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

For residual pest control in, on, and around buildings and structures and their immediate surroundings and on modes of transport. Permitted areas of use include, but are not limited to, industrial buildings, houses, apartment buildings, laboratories, buses, greenhouses, stores, warehouses, vessels, railcars, trucks, trailers, aircraft, schools, nursing homes, hospitals, restaurants, hotels, livestock housing, pet kennels grant grant and food manufacturing, processing and servicing establishments.

COMMODORE WP can be reapplied at 21 day intervals if necessary.

STORAGE AND DISPOSAL

PROHIBITIONS: Do not contaminate water, food, or feed by storage or disposal. Do not use empty container.

STORAGE: Mix as needed. Do not store diluted material. Do not store near food or feed, In case of spill on floor or paved surfaces, sweep up and remove to chemical waste storage area until proper disposal can be made.

Application Equipment Preparation

For best results, thoroughly wash out sprayer and screens with water and detergent before using COMMODORE® WP insecticide. To avoid sprayer clogging, do not use strainers or screens finer than 50 mesh size.

Mixing Procedures

COMMODORE WP insecticide is intended for dilution with water for applications. For best results, dilution should be achieved if the following steps are taken:

- 1. Fill applicator tank 1/2 with water.
- 2. Add desired COMMODORE WP insecticide.
- 3. Allow 1-2 minutes for dissolution.
- 4. Agitate, stir or shake applicator tank.
- 5. Finish filling applicator tank and agitate again before use to ensure satisfactory suspension.

Note:

- Upon standing without agitation for more than 1 hour, the applicator tank should be agitated stiffed or shaken to achieve satisfactory suspension.
- Make up only amount of application volume as required.
- This product should not be applied with oil.

Tank Mixing

COMMODORE WP insecticide may be tank mixed with other currently registered pesticides unless expressly prohibited by the product label. A small volume mixing test with the other products is recommended to ensure compatibility.

Observe all restrictions and precautions which appear on the labels of these products.

- 1. ANTS: Apply to any trails around doors and windows and other places where ants may be found. Apply barrier treatments to prevent infestation as directed below; also see OUTDOOR USE.
- 2. COCKROACHES, SPIDERS, CRICKETS, SILVERFISH, AND FIREBRATS: Apply as a coarse, low pressure spray to areas where these pests hide, such as baseboards, corners, storage areas, closets, around water pipes, doors and windows, attics and eaves, cabinets, behind and under refrigerators, sinks, furnaces, and stoves, the underside of shelves, drawers and similar areas. Pay particular attention to cracks and crevices; also see OUTDOOR USE.
- 3. BEES, FLIES, MOSQUITOES, AND WASPS: Apply directly to walls, ceilings, window screens, and other fly resting areas as a residual surface treatment. May be used inside residential buildings as well as in and around carports, garages, and storage sheds; also see OUTDOOR USE.

Spray freat baseboards, storage areas, and other locations. Apply barrier treatments to prevent infestation as described below; also see OUTDOOR USE.

Authorized by the USDA for use in edible areas of Federally inspected meat, poultry, and egg processing areas as a crack and crevice or spot spray treatment.

Application Within Food Serving Areas: (facilities where foods are served, such as dining rooms): Apply as a crack and crevice or spot treatment to selective surfaces such as baseboards, under elements of construction, and into cracks and crevices. Avoid treating surfaces likely to be contacted by food. (Do not apply when facility is in operation or foods are exposed.)

Application of this product in the Food Areas and/or Food Serving Areas of Food Handling Establishments other than as a spot and/or crack and crevice treatment is not permitted.

Livestock Housing Structures and Pet Kennels

Also may be applied to home lawn areas around residential non-residential buildings. lawn sites only refuse dumps, and similar areas where these insect pests are found active.

BARRIER TREATMENTS: To help prevent infestation of building, apply to a band of soil and vegetation 6 to 10 feet wide around and adjacent to the building. Also, treat the building foundation to a height of 2 to 3 feet where pests are active and may find entrance.
