Your June 18, 1997 and September 4, 1997 Submissions

The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act, as amended, is acceptable provided that you make the labeling changerindicated below prior to release for shipment of product bearing the amended labeling.

- 1. In the Environmental Hazards statement, change "Do not apply directly to water" to "Do not apply directly to water or to areas where surface water is present or to intertidal areas below the mean high water mark".
- 2. Under Food Serving Areas change "should be covered" to "must be covered". Also, reinstate "Do not apply when facility is in operation" to this section. This is required when treating dining facilities.
- 3. Following the last sentence under Application Within Food Handling Establishments add "Food contact surfaces and equipment should be cleaned with an effective cleaning compound and rinsed with potable water before using". This is stated under 40 CFR 180.438 (previously 185.3765) but was overlooked in earlier reviews.
- 4. Delete the entire section entitled Application in Food Storage Facilities or Transportation Vehicles. The product is not approved for use on food surfaces. The regulation states that spray should not be applied to surfaces that may come in contact with food.

Submit two copies of your final printed labeling before you release the product for shipment. If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA section 6(e). Your release for shipment of the product bearing the amended labeling constitutes acceptance of these conditions.

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

For use as a general surface (nonfood/nonfeed areas), crack and crevice or spot treatment residual pest control in, on, and around buildings and structures and their immediate surroundings and on modes of transport. Permitted areas of use include, but are not limited to, industrial buildings, houses, apartment buildings, laboratories, buses, greenhouses, stores, warehouses, vessels, railcars, trucks, trailers, aircraft (cargo areas only), schools, nursing homes, hospitals, restaurants, hotels, livestock poultry housing, pet kennels, food granaries, food grain mills and food manufacturing, processing and servicing establishments.

COMMODORE WP Insecticide can be reapplied at 21 day intervals if necessary.

STORAGE AND DISPOSAL

PROHIBITIONS: Do not contaminate water, food, or feed by storage or disposal. Do not use empty container.

STORAGE: Mix as needed. Do not store diluted material. Do not store near food or feed. In case of spill on floor or paved surfaces, sweep up and remove to chemical waste storage area until proper disposal can be made.

Mixing Procedures

COMMODORE WP insecticide is intended for dilution with water for applications. For best results, dilution should be achieved if the following steps are taken:

- 1. Fill applicator tank 1/2 with water.
- 2. Add desired COMMODORE WP insecticide.
- 3. Allow 1-2 minutes for dissolution.
- 4. Agitate, stir or shake applicator tank.
- 5. Finish filling applicator tank and agitate again before use to ensure satisfactory suspension.

- Upon standing without agitation for more than 1 hour, the applicator tank should be agitated, stirred or shaken to achieve satisfactory suspension.
- Make up only amount of application volume as required.

Tank Mixing

- 1. ANTS: Apply to any trails around doors and windows and other places where ants may be found. Apply barrier treatments to prevent infestation as directed below; also see OUTDOOR SURFACES USE.
- 2. COCKROACHES, SPIDERS, CRICKETS, SILVERFISH, AND FIREBRATS: Apply as a coarse, low pressure spray to areas where these pests hide, such as baseboards, corners, storage areas, closets, around water pipes, doors and windows, attics and eaves, cabinets, behind and under refrigerators, sinks, furnaces, and stoves, the underside of shelves, drawers and similar areas. Pay particular attention to cracks and crevices; also see OUTDOOR SURFACES USE.
- 3. BEES, CARPENTER BEES, FLIES, MOSQUITOES, AND WASPS: Apply directly to walls, ceilings, window screens, and other fly resting areas as a residual surface treatment. Application Within Food Handling Establishments: (places other than private residences in which exposed food is held, processed, prepared, or served) including, but not limited to, areas for receiving, storage, packing (canning, bottling, wrapping, boxing), preparing foods, edible waste storage and enclosed processing systems (mills, dairies, edible oils, syrups) and serving areas. Apply in small amounts directly into cracks and crevices, using equipment capable of delivering a pin stream of insecticide, in points between different elements of construction, between equipment and floor, openings leading to voids and hollow spaces in walls, equipment and bases.

Limit individual spot treatments to an area no larger than 20% of the treated surface. Individual spot treatments should not exceed two square feet. Application Within Food Serving Areas: (facilities where foods are served, such as dining rooms): Apply as a crack and crevice or spot treatment to selective surfaces such as baseboards, under elements of construction, and into cracks and crevices. Avoid treating surfaces likely to be contacted by food. (Do not apply when facility is in operation or foods are exposed.) Food should be covered or removed in area being treated. Do not apply directly to food or allow applications to contaminate food.

Application of this product in the Food Areas and/or Food Serving Areas of Food Handling Establishments other than as a spot and/or crack and crevice treatment is not permitted.

Applications in Food Storage Facilities or Transportation Vehicles: Crack and crevice or spot treatments may be made in storage areas of transportation vehicles, food granaries, food grain mills, warehouses and production facilities only before storing or filling with the food products of food grains. COMMODORE WP may be applied by pest control operators or food grain producers in these areas to help control insect infestations of the stored foods as a crack and crevice or spot freatment at the rates recommended in the use rate table. Normal cleaning practices of the storage facilities or transportation vehicles must be followed along with application of COMMODORE WP to effectively control stored food pests listed in the rate table.

Livestock/Poultry Housing Structures and Pet Kennels

Apply as a general surface and/or crack and crevice treatment. Control is enhanced when interior and exterior perimeter applications are made in and around the livestock poultry and pet housing structures. Normal cleaning practices of the structure also must be followed along with applications of COMMODORE WP Insecticide to effectively control the crawling and flying insect pests listed in the table.

For poultry houses, apply to floor area (birds grown on litter) or to walls, posts, and cage framing (birds grown in cages). Application should also be made into cracks and crevices around insulation. Reapply after each growout or sanitization procedure. Indoor control can be enhanced by making perimeter treatments around the outside of building foundations to prevent immigrating adult beeties. Apply in a uniform band at least one foot up and one foot out from foundation. Maintaining a year-round treatment program will prevent background populations from reaching problem levels.

DO NOT make applications of COMMODORE WP Insecticide when in areas where animals are present in the facility. Allow treated surfaces to completely applications to dry before restocking the facility.

DO NOT make applications to any animal feedstuffs water or watering equipment.

OUTDOOR SURFACES USE

For control of ants, bees, centipedes, cockroaches, crickets, fleas, flies, millipedes, mosquitoes, scorpions, sowbugs, pillbugs, spiders, ticks, and wasps and other similar perimeter insect pests. Apply with either hand or power sprayer application equipment as a residual treatment to surfaces of buildings, porches, screens, window frames, eaves, patios, garages, and other similar areas. Also may be applied to lawn areas around residential/non-residential buildings, refuse dumps, and similar areas where these insect pests are active.

BARRIER TREATMENTS: To help prevent infestation of building, apply to a band of soil and vegetation 6 to 10 feet wide around and adjacent to the building. Also, treat the building foundation to a height of 2 to 3 feet where pests are active and may find entrance. Apply as a coarse spray to theroughly and uniformly wet the foundation and/or band area, using 1 gallon of spray mix per 400-1000 square feet.

NOTE: Do not use water base sprays of COMMODORE WP Insecticide in conduits, motor housings, junction boxes, switch boxes, or other electrical equipment because of possible shock hazard. For best results, thoroughly wash out sprayer and screen with water and detergent before using COMMODORE WP insecticide. COMMODORE WP insecticide has not stained or caused damage to painted or varnished surfaces, plastics, fabrics or other surfaces where water applied alone causes no damage.

- Let treated surfaces dry before allowing humans and pets to contact surfaces.
- Do not apply this product in any room being used as living, eating, sleeping or recovery area by patients, the elderly, or infirm when they are in the room.
- Do not apply to classrooms when in use.
- Do not apply this product to edible growing crops or stored raw agricultural commodities use for food or feed.
- Do not allow applications to contact water inhabited by fish, such as in aquariums and ornamental fish ponds that are located in/around structures being treated.
