
WHAT THIS ACCEPTANCE MEANS:



Mixers/loaders when mixing and loading this product must wear a long sleeved shirt and long pants or a coverall that covers all parts of the body except the head, hands and feet. Wear shemical resistant gloves, goggles or a face shield and chemically resistant apron.

Fieldworkers and harvesters must wear chemical resistant gloves if entering treated areas within 4 days following application. Leather or fabric gloves are not acceptable.

A dust mask must be worn when mixing and loading this product.

AFTER-WORK: Take off-all-clothes and shoes. Shower using soap and water. Do not wear contaminated clothing. Wash protective clothing and equipment with soap and water after with each use. Cut pieces should be treated within 6 hours of cutting. If planting is to be delayed more than 1 or 2 days the treated pieces should be stored for 2 days in open crates before bagging.

Do not use treated seed pieces for food or feed.
