

The labeling cited above and submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), as amended, is accepted subject to the comments reflected on the enclosed sheet. A copy of your proposed labeling stamped "ACCEPTED WITH COMMENTS" is enclosed.

WHAT THIS ACCEPTANCE MEANS:

Based on your certification, the Agency has accepted the labeling changes that are necessary to comply with the Worker Protection Standard (WPS) labeling requirements of 40 CFR part 156, subpart K, described in PR Notices 93-7 and 93-11. Any other labeling changes submitted in connection with this amendment application but not directly related to compliance with the WPS have not been reviewed or accepted by the Agency. If you wish to make such changes, you must submit a separate amendment application proposing them. If your product is currently suspended, the acceptance of this labeling amendment does not affect the suspension in any way.

WHAT YOU NEED TO DO NEXT:

By the next label printing make all the specified changes to your labeling. Send to EPA one (1) copy of the final printed labeling:

The following specific comments pertain to your WPS labeling submission concerning the product cited above:

User Safety Recommendations must either be placed in a box or printed on the label in a contrasting color from surrounding text.

The Agricultural Use Requirements section must be located in a clearly separate box on the product labeling -- with lines or other graphic indicators (such as contrasting color) to separate the section from the surrounding text.

The following statement on your proposed label is not required for this product: "Notify workers of the application by warning them orally and by posting warning signs at entrances to treated areas." Delete it from the Agricultural Use Requirements box.

Delete the crossed-out statements on your proposed label. They are redundant statements or phrases.

REENTRY STATEMENT

Keep all unprotected persons out of operating areas or vicinity where there may be danger of drift.

Do not allow person to enter treated areas within 4 days following application unless a long sleeved shirt and long pants or a coverall that covers all parts of the body except the head, hands and feet and chemically resistant gloves are worn. Conspicuously post reentry information at site of application.

Certain states may require more restrictive reentry intervals; consult-your State Department of Agriculture for further information. Written or oral warnings regarding use of protective elething and accidental exposure must be given to workers who are expected to be in-treated areas or in areas about to be treated.

Mixers/loaders when mixing and loading this product must wear a long sleeved shirt and long pants or a coverall that covers all parts of the body-except the head, hands and feet. Wear chemical resistant gloves, goggles or a face shield and a chemically resistant apron.

Fieldworkers and harvesters must wear ohemical-resistant gloves if entering treated areas within 4 days following application. Leather or fabric gloves are not acceptable:

A dust-mask must be worn when mixing and loading this product.

During application only, if from a tractor with a completely enclosed cab a long sleeved shirt and long legged pants must be worn. Chemically resistant gloves must be available in the cab and wom while exiting.

AFTER WORK: Take off all clothes and shoes. Shower using soap and water. Do not wear contaminated clothing. Wash protective clothing and equipment with soap and water after each use. Personal clothing worm during use must be laundered separately from household articles. Clothing and protective equipment heavily contaminated or drenched with captan must be destroyed according to state and local regulations.

ORNAMENTALS: ROSES - Black Spot. CARNATIONS - Rust and Leaf Spot. CHRYSANTHEMUMS - Flower Blight - Apply at first sign of disease to give even coverage of upper and lower leaf surfaces. Repeat at 7 to 10 day intervals as necessary.

POTATOES: (Seed Pieces): Damp Off - Dust at 7½ ounces per bushel cut seed pieces (12 oz. or 3/4 lb. to 100 lbs. cut seed pieces). Apply in convenient container or by duster attachment over belt. Cut pieces should be treated within 6 hours of cutting. If planting is to be delayed more than 1 or 2 days the treated pieces should be stored for 2 days in open crates before bagging. Do not use treated seed for food or feed purposes.

SOIL AND GREENHOUSE BENCH TREATMENT: Preplanting for Damp Off and Root Rot Diseases on Seedling or Transplants of Roses (and other shrubs and trees), Many Flowers and Lawn Seedbeds - 1½ to 1½ lbs per 1000 sq. ft. (50 to 60 lbs. per acre). Work into upper 3 to 4 inches of soil before planting. Only the applicator is permitted to be in the greenhouse

during application of Captan. Open vents to greenhouse during application and for at least 1 hour after application. Workers planting in Captan treated soil in greenhouses must wear chemical resistant gloves.

STOCK: Botrytis Rot - Use 40 to 50 lbs. per acre. Apply when disease appears. Repeat at weekly intervals as needed.

TURF, LAWN: Brown Patch, Leaf Spot, Damp Off, Root Rot - Use 1 to 2 lbs. per 1000 sq. ft. Treat before infection occurs. Repeat at 7 to 10 day intervals throughout summer.

COMPATIBILITY: Do not use this product on foliage closely following oil sprays.

Do not apply under conditions involving possible drift to food, forage or other plantings that might be damaged or the crops thereof rendered unfit for sale, use or consumption.

STORAGE AND DISPOSAL
