GLADIOLUS: Dry Rot (Stromatinia) - Soil - Use 250 lbs. per 14,520 linear feet of furrow. Dust into furrow at planting time, so treated soil surrounds corms. Foliage - Use 30 lbs. per acre, dust thoroughly to insure coverage between spikes. Apply to bunched flower spikes after harvest and before shipment or storage.
