Your Submission Dated March 31, 1995

The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, is acceptable with the following provisions:

1) The company name "ICI Americas" still appears in the paragraph immediately before the Ingredient statement on the front panel. This should be revised to reflect the new company name.

2) Rewrite the Environmental Hazards section to read as follows:

"Do not discharge effluent containing this product into lakes, streams, ponds, estuaries, oceans or other waters unless in accordance with the requirements of a National Pollutant Discharge Elimination System (NPDES) permit and the permitting authority has been notified in writing prior to discharge. Do not discharge effluent containing this product to sewer systems without previously notifying the local sewage treatment plant authority. For guidance contact your State Water Board or Regional Office of the EPA."

A stamped copy is enclosed for your records. Please submit one (1) final printed copy for the referenced label, incorporating the above changes, before releasing the product for shipment.

STATEMENT OF PRACTICAL TREATMENT

IF SWALLOWED: IMMEDIATELY give water or milk to drink and induce vomiting by inserting finger in throat. Take person and product container to the nearest hospital or physician fast. **PROMPT TREATMENT IS ESSENTIAL TO COUNTERACT POISONING** and should be initiated before signs and symptoms of injury appear.

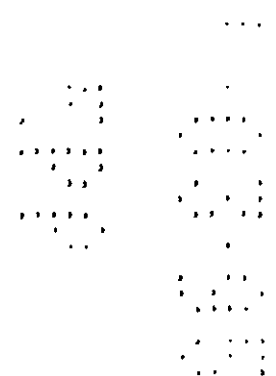
