Subject: Revised Labeling - Revised Ingredient Statement Reward Manufacturing Concentrate EPA Registration No. 10182-355 Your Submission Dated August 9, 1999

The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act, as amended, is acceptable with the following provisions:

- 1) We note the abbreviated precautionary statement on the front panel reading "Do not inhale. Do not get on skin." The complete Precautionary Statements is then appropriately referred to elsewhere on the label. Whereas the abbreviated precautionary language along with a referral to the remaining language is acceptable, the abbreviated language should include a segment for each of the most highly toxic categories for the product. Therefore, add a statement reading "Do not get in eyes" to the abbreviated precautionary language.
- 2) Revise the dermal statement, eye statement, and inhalation statement in the Statement of Practical Treatment to read as follows:

"IF ON SKIN: Wash with plenty of soap and water. Get medical attention."

"IF IN EYES: Hold eyelids open and flush with a steady, gentle stream of water for 15 minutes. Get medical attention."

"IF INHALED: Remove victim to fresh air. If not breathing, give artificial respiration, preferably mouth-to-mouth. Get medical attention."

We note the inclusion of the word "immediately" that currently appears in the beginning of each statement of practical treatment (e.g., "IMMEDIATELY wash with plenty of soap and water..."). This inclusion is an acceptable and may be retained at your option.

- 3) Make the following revisions to the Precautionary Statements:
  - a) Revise the first sentence to read "May be fatal if absorbed through skin."
  - b) Add the statement "Harmful if swallowed or inhaled."
  - c) Add the statement "Avoid breathing vapors."
- 4) We note missing language in the beginning of the Warranty statement. Specifically, the second sentence in the shaded area (after the Notice heading) is incomplete. This statement should be reinstated as previously approved on February 9, 1995.

A stamped copy is enclosed for your records. Please submit one (1) final printed copy for the referenced label, incorporating the above changes, before releasing the product for shipment.

The Agency has also reviewed your submission for the revised Confidential Statement of Formula dated August 6, 1999 for the basic formulation. It has been determined that the Confidential Statement of Formula agrees with the label claim in compliance with PR Notice 91-2 and is acceptable. The Confidential Statement of Formula has been added to your file as part of the record.
