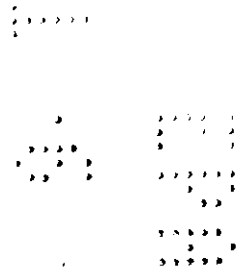

### STATEMENT OF PRACTICAL TREATMENT

**IF SWALLOWED:** IMMEDIATELY give water or milk to drink and induce vomiting by inserting finger in throat. Take person and product container to the nearest hospital or physician fast. PROMPT TREATMENT IS ESSENTIAL TO COUNTERACT POISONING and should be initiated before signs and symptoms of injury appear.
