e. Under footnote 2 add:

". . per 2.5 gallons of water and thoroughly cover and soak each mound and treat a 4 foot diameter circle around the mound. Apply mixture gently to avoid disturbing the mound. Disturbing the mound may disturb the ants and cause migration, thus reducing effectiveness of treatment. For best results apply in cool weather, such as in early morning or late evening hours, but not in the heat of the day. Make additional treatments as needed."

3. Submit five copies of your final printed labeling before you release the product for shipment. Refer to the A-79 Enclosure for a further description of final printed labeling.

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA sec. 6(e). Your release for shipment of the product constitutes acceptance of these conditions.

MIXING: Do not allow packs to become wet before adding to the spray tank. Wear dry rubber gloves when handling water-soluble packs. Minimize handling of packs since excessive handling may cause rupture. SCIMITAR™ WP insecticide is intended for dilution with water for spray application and may be used in all types of spray equipment. Fill sprayer with 1/2 volume of water and add water-soluble pack(s) of SCIMITAR WP and then fill to desired volume. Wait 2 minutes for pack(s) to dissolve. Close and shake before use in order to ensure proper suspension of the wettable powder. Shake or reagitate sprayer before use if spraying is interrupted. Make up only as required.

COMPATIBILITY: SCIMITAR WP has been found to be compatible with all commonly used fungicides, miticides, liquid fertilizers, and other insecticides. Check physical compatibility using the correct proportion of products in a small jar if local experience is unavailable.

APPLICATION: SCIMITAR WP insecticide mixes readily with water and may be used in all types of spray equipment. Mix product with the required amount of water and apply as a dilute spray application to the point of runoff. When spraying hard-to-wet foliage such as holly, pine, or ivy, the addition of a spreader sticker may enhance knockdown and residual activity. If concentrate or mist-type spray equipment is used, an equivalent amount of product should be used on the area sprayed as would be used in a dilute application. Phytotoxicity testing has been carried out on a wide range of ornamental plants under various environmental conditions, and no phytotoxicity has been observed. It is advised to prespray a selection of ornamentals if local use experience is unavailable.

IMPORTANT: Time application to flowering plants during periods of time when pollinating insects are not present, such as early morning or late evening.
