Your Amended Applications Dated March 17, 1993

The labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act as amended is accepted. Submit five (5) copies of your final printed labeling bearing the amended labeling before you release the products for shipment.

Note for EPA Reg. No. 10182-360, at the next printing of labeling for the water-soluble bags (WSB), you must include at minimum, the package name, signal wording, keep out reach of children, ingredient, and referral statement, along with the EPA Reg. Number. Refer to the enclosed excerpt from FR Notice dated September 26, 1984 regarding unit packaging. In addition, you must submit a revised confidential statement of formula which include the ink used for printing this information on the WSB. In lieu of the above information you may select to package only one WSB per foil.

Stamped copies of the labeling is enclosed for your records.

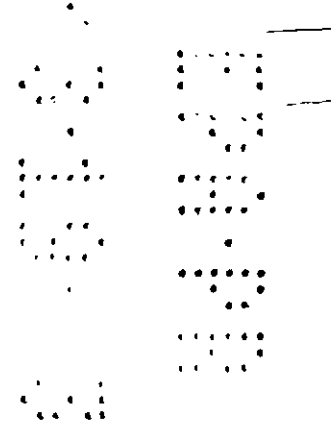

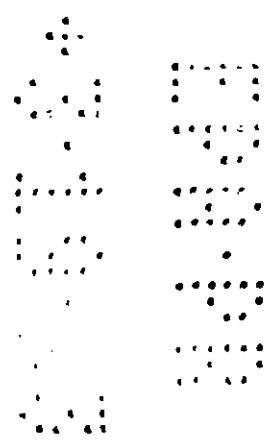

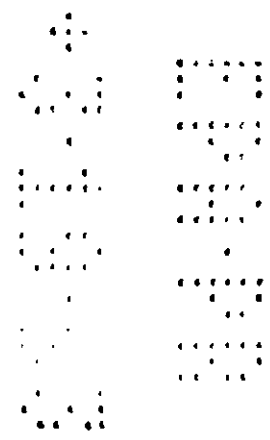

This product is extremely toxic to fish. Do not contaminate water when disposing of equipment washwaters. Do not apply directly to water or to areas where surface water is present, or to intertidal areas below the mean high water mark. Drift and runoff from treated areas may be hazardous to aquatic organisms in neighboring areas. Apply this product only as specified on this label. Care should be used when spraying to avoid fish and reptile pets.

DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

MIXING: Do not allow packs to become wet before adding to the spray tank. Wear dry rubber gloves when handling water-soluble packs. Minimize handling of packs since excessive handling may cause rupture. SCIMITAR™ WP insecticide is intended for dilution with water for spray application and may be used in all types of spray equipment. Fill sprayer with 1/2 volume of water and add water-soluble pack(s) of SCIMITAR WP and then fill to desired volume. Wait 2 minutes for pack(s) to dissolve. Close and shake before use in order to ensure proper suspension of the wettable powder. Shake or reagitae sprayer before use if spraying is interrupted. Make up only as required.

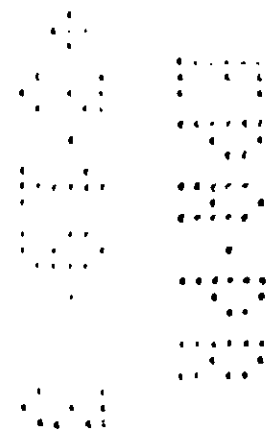
COMPATIBILITY: SCIMITAR WP has been found to be compatible with all commonly used fungicides, miticides, liquid fertilizers, and other insecticides. Check physical compaibility using the correct proportion of products in a small jar if local experience is unavailable.

APPLICATION: SCIMITAR WP insecticide mixes readily with water and may be used in all types of spray equipment. Mix product with the required amount of water and apply as a dilute spray application to the point of runoff. When spraying hard-to-wet foliage such as holly, pine, or ivy, the addition of a spreader sticker may enhance knockdown and residual activity. If concentrate or mist-type spray equipment is used, an equivalent amount of product should be used on the area sprayed as would be used in a dilute application. Phytotoxicity testing has been carried out on a wide range of ornamental plants under various environmental conditions, and no phytotoxicity has been observed. It is advised to prespray a selection of ornamentals if local use experience is unavailable.

IMPORTANT: Time application to flowering plants during periods of time when pollinating insects are not present, such as early morning or late evening.

DO NOT APPLY THIS PRODUCT THROUGH ANY TYPE OF IRRIGATION SYSTEM.

²To control ants effectively, the mound must be treated with a drench application. Use 1 pack of SCIMITAR WP per 2.5 gallons of water and thoroughly cover and soak each mound and treat a 4 foot diameter circle around the mound. Apply mixture gently to avoid disturbing the mound. Disturbing the mound may disturb the ants and cause migration, thus reducing effectiveness of treatment. For best results apply in cool weather, such as in early morning or late evening hours, but not in the heat of the day. Make additional treatments as needed.

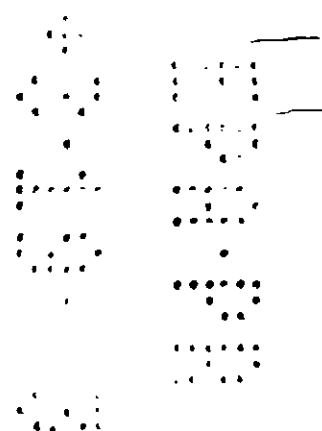
STORAGE AND DISPOSAL

PROHIBITIONS: Do not contaminate water, food, or feed by storage or disposal. Do not reuse empty container.

STORAGE: Mix as needed. Do not store diluted material. Do not store near food or feed. In case of spill on floor or paved surfaces, sweep up and remove to chemical waste area. Keep water-soluble packs in original foil package and store in cool dry place. Do not store below 32°F. Handle carefully when stored at temperatures less than 50°F to avoid breakage of packs.

PESTICIDE DISPOSAL: Wastes resulting from the use of this product may be disposed of on site or at an approved waste disposal facility.

CONTAINER DISPOSAL: When all packs are used, dispose of foil package in a sanitary landfill, by incineration, or, if allowed by State and local authorities, by burning. If burned, stay out of smoke.
