Application to turf should be started prior to the establishment of high insect pest populations under control, using higher rates as pest pressure increases.

Apply at 7-day intervals if treatment is necessary.

Do not apply more than 0.36 pounds of active ingredient (52.4 fl oz of concentrate) per acre per year.

For spot treatments use 0.5 fl. oz. of SCIMITAR GC per 1 to 2½ gallons of water.
