<p>1. Replace the paragraph under the "Environmental Hazards" heading with the following:</p>		
<p>This pesticide is toxic to fish and aquatic organisms. Do not discharge effluent containing this product into lakes, streams, ponds, estuaries, oceans or public waters unless this product is specifically identified and addressed in an NPDES permit. Do not discharge effluent containing this product to sewer systems without previously notifying the sewage treatment plant authority. For guidance contact your State Water Board or Regional Office of the EPA.</p>

4. In the ingredients statement, change Active Ingredients to the singular Active Ingredient.
5. Above the "Directions for Use" heading, in the statement, "For all Fruits, Vegetable, Meat and Poultry Processing Plants..." change the word "Fruits" to the singular "Fruit" for clarity.

A stamped copy of the product label is enclosed for your records.

Submit one copy of the final printed labeling before releasing the product in channels of trade with the revised labeling.

If these conditions are not complied with, the registration will be subject to cancellation in accordance with FIFRA sec. 6(e). Your release for shipment of the product constitutes acceptance of these conditions.
