This product was first granted a time limited registration subject to our completion of an environmental risk assessment. We have completed our risk assessment and find we have concerns regarding the potential for Irgarol to impact aquatic plants, espeially seagrass beds which are important as a nursery area and habitat for higher order species. We are concern that Irgarol is showing a trend to be an environmental problem. In order to allow you time to address our concerns we are extending this time limited registration to January 15, 2004. You were provided a copy of our risk assessment with a letter dated August 20,2003.

2. Revise the First Aid statements to read:

"FIRST AID

DIRECTIONS FOR USE

APPLICATION INSTRUCTIONS: Stir thoroughly and apply to a clean dry surface with a temperature above the dem point. Apply over HEMPATEX 4633 or according to specifications. Film thickness and number of coats depend upon hull condition, trading pattern, and extended service life. Allow at least 10 hours dry time between coats of ANTIFOULING 71990 at 20C/68F. Drying time is proportionally longer at lower temperatures. If thinning is required for brush, roller, conventional spray or airless application, use HEMPEL'S THINNER No. 0808. Equipment should be promptly cleaned with THINNER 0808 after use. The ship may be floated when final coat of paint is dry for 12 hours. Prolonged expesure to the atmosphere may affect the properties of HEMPEL'S ANTIFOULING 71990.
