

# STA-PUT 1200 WEED KILLER

## DIRECTIONS

To control most weeds and grasses for extended periods on non-cropland areas such as industrial plant sites, parking lots, loading ramps and around storage buildings and the like apply 1 to 4 gallons per 1000 square feet of STA-PUT 1200 after the most predominant weeds have emerged. No agitation is required. STA-PUT 1200 can be applied with standard spray equipment. For treating small areas, a tank type hand sprayer or sprinkling can may be used.

NOTE: Users should consult State Agricultural Experiment Stations or Extension Service Weed Specialists for recommendations as to use of STA-PUT 1200 in their particular area, or write to Venus Laboratories, Inc.

**IMPORTANT:** Do not apply directly to, or otherwise permit STA-PUT 1200 to contact susceptible plants as this product may injure cotton, beans, peas, grapes, flowers, fruit trees, ornamentals or other desirable plants. Avoid spray drift to such susceptible plants (coarse sprays are less likely to drift.) Vapors from this product may injure susceptible plants in the immediate vicinity. Do not apply to areas under laid by roots of desirable trees and shrubs. Thoroughly clean spray equipment with a suitable chemical cleaner before using for other purposes (or do not use same equipment for other purposes.) Do not store near fertilizers, seeds, insecticides or fungicides. Do not reuse this container.
