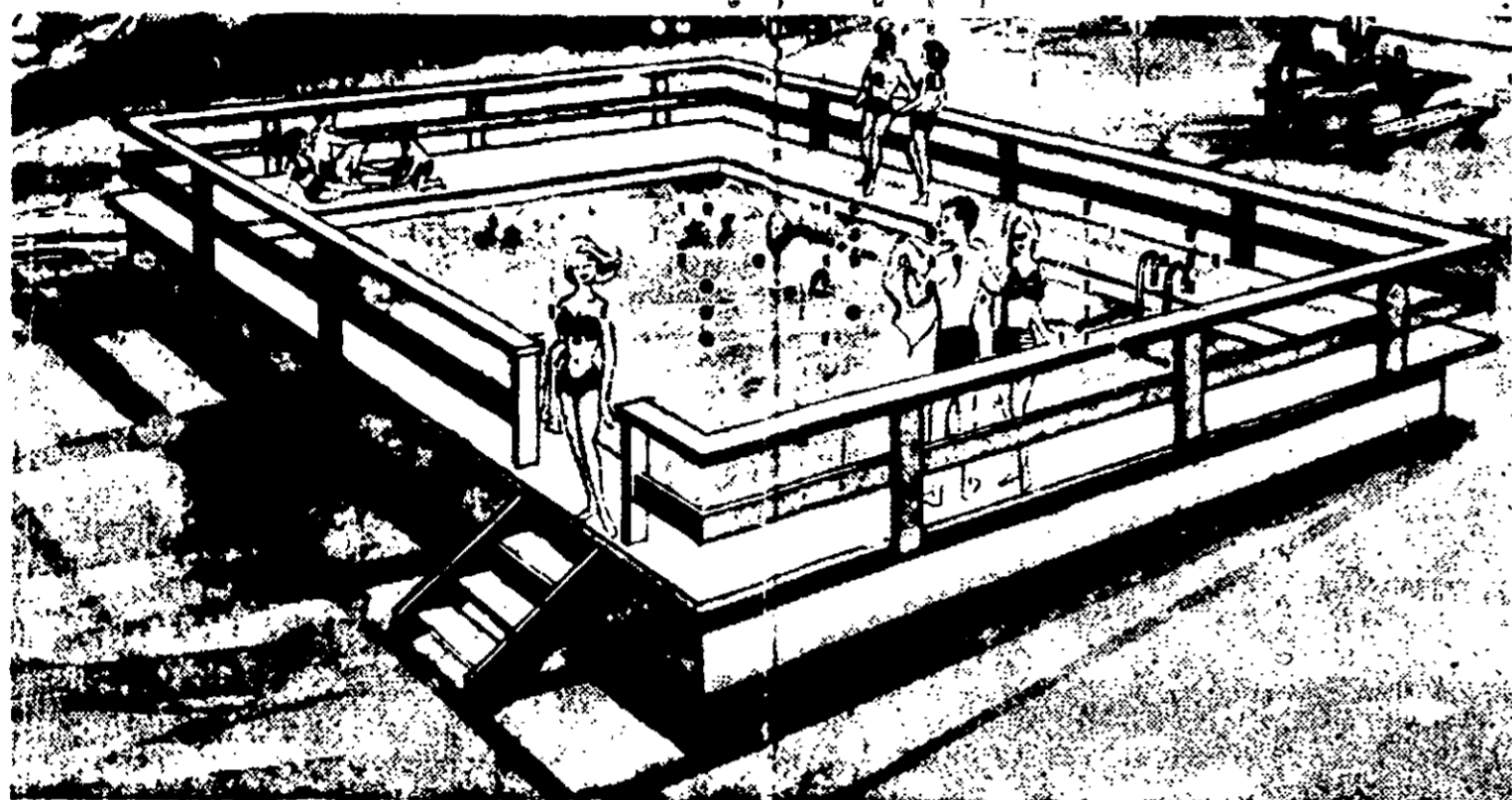

DIRECTIONS: 1. In freshly filled pools or pools showing no visible algae growth add 5 fl. oz. PRODUCT C per 10,000 gals. of water to prevent algae growth. 2. If algae growth is observed, add one quart PRODUCT C for each 25,000 gals. of water to kill and control those algae species most commonly found in swimming pools. When existing growth is dead, clean the pool, drain and refill if necessary, and add 5 fl. oz. PRODUCT C per 10,000 gals. of water. 3. If the pool water treated as in (1) or (2) above is recycled, add 5 fl. oz. PRODUCT C per 10,000 gals. of water every 5 to 7 days to maintain between 2 and 5 ppm of active ingredient. See serviceman for test kit. 4. If the pool water treated as in (1) or (2) above is not recycled or not filtered it should be tested periodically to determine the active ingredient content. Add 5 fl. oz. PRODUCT C per 10,000 gals. of water to maintain 2 to 5 ppm of active ingredient.

This product is toxic to fish. Do not discharge treated effluent where it will drain into lakes, streams or ponds.

DANGER: KEEP OUT OF REACH OF CHILDREN. Corrosive. Causes eye damage and skin irritation. Do not get in eyes, on skin or on clothing. Wear goggles or face shield and rubber gloves when handling. Harmful or fatal if swallowed. Avoid contamination of food.

FIRST AID: In case of contact, immediately flush eyes or skin with plenty of water for at least 15 minutes. For eyes, call a physician. Remove and wash contaminated clothing before reuse. If swallowed, drink promptly a large quantity of milk, egg whites, gelatin solution or if these are not available, drink large quantities of water. Avoid alcohol. Call a physician immediately.

NOTE TO PHYSICIAN: Probable mucosal damage may contraindicate the use of gastric lavage. Measures against circulatory shock, respiratory depression and convulsion may be needed.

CONTAINER DISPOSAL: Do not reuse empty container. Destroy it by perforating or crushing. Bury or discard in a safe place.
