Following review of the residue data submitted in support of the IR-4 petition (71 FR 67571, November 22, 2006), EPA made several revisions to the petitioners request for the establishment of pyriproxyfen tolerances. Due to the absence of confirmatory data, the Agency did not establish the tolerance proposed for: vegetables, leaves of root and tuber, group 2; vegetable leafy except Brassica, group 4; vegetable foliage of legume, group 7; artichoke, globe; asparagus; kiwifruit; and watercress (72 FR 46914-46919, August 22, 2007). A tolerance petition for vegetable, legume, group 6 was removed from the petitioners request because a tolerance of 0.20 ppm pyriproxyfen was already established for this group (40 CFR 180.510). Therefore, the labeling referred to above, submitted in connection with registration under the Federal Insecticide, Fungicide and Rodenticide Act, is acceptable provided you:

- 1. Remove the following crops from the label:
  - a. artichoke, globe
  - b. asparagus
  - c. kiwifruit
  - d. vegetable, leafy, except Brassica, (crop group 4)
  - e. watercress
- 2. Submit the results of an in vivo cytogenetics study (OPPTS Guideline 870.5385) by June 1, 2009. Please see the attached human health risk assessment for more information.
- 3. Refer to PR Notice 2007-4 "Standards for Pesticide Containers and Containment" and revise your label accordingly.

Submit three (3) copies of your final printed labeling for each product before releasing the product for shipment. If these conditions are not complied with, the registration(s) will be subject to cancellation in accordance with FIFRA section 6(e). Your release for shipment of the product bearing amended labeling constitutes acceptance of these conditions.

A stamped copy of the label is enclosed for your records together with the human health risk assessment, ecological risk assessment, and summary of analytical chemistry and residue data.
