

2. PYNAMIN FORTE 60 MOSQUITO MAT efficiently destroys mosquitoes and flies in a room of up to 2300 cu. ft. (approximately 15 x 19 x 8 ft.)
3. One PYNAMIN FORTE 60 MOSQUITO MAT lasts ten hours.
4. PYNAMIN FORTE 60 MOSQUITO MAT turns white when active ingredients have been exhausted.
5. To change mat, unplug heater, turn upside down and allow PYNAMIN FORTE 60 MOSQUITO MAT to fall out.
6. For indoor use only when mosquitoes are an annoyance.
7. Do not use in rooms while people are sleeping.
