For formulation into end-use cockroach baits intended only for indoor food and non-food use areas.

Use Sumithion 20 MC as the active ingredient for formulating cockroach baits. Sumithion 20 MC is added to suitable baits to give 5% by weight of the total formulation. The treated bait is then dispensed into bait stations at 0.5 oz per station or similar weight, or is applied to substrates frequented by cockroaches. The bait stations are then sealed.

Since Sumithion 20 MC is intended for sale to formulators of different brands of cockroach baits, as well as pest control operators who formulate their own baits, precise instructions for formulation are not possible. Formulators are responsible for registering their own baits containing Sumithion 20 MC, and for following all relevant regulations for their sale, use, storage and disposal.

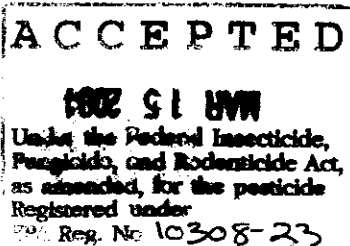
