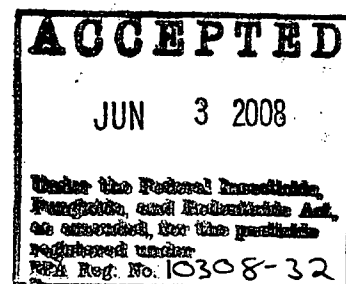

This product is intended only for use in the formulation of Clothianidin containing insecticide products. Products formulated with Clothianidin Technical will require registration with the U. S. Environmental Protection Agency.

DIRECTIONS FOR USE

Only for formulation into insecticide products intended for the following uses:

Terrestrial Food Crops: Canola, Corn (including field, pop and sweet), Grapes, Pome Fruit Crop Group 11, Potato, Rapeseed, Sorghum, Sugar Beet and Tobacco.

Terrestrial Non-Food Crops: Turfgrass, Sod Farms, Ornamentals, Interior plantscapes, Non-bearing fruits and nuts (in landscape)

Formulators who use this product are responsible for providing data to support their own registrations.

PESTICIDE STORAGE
