

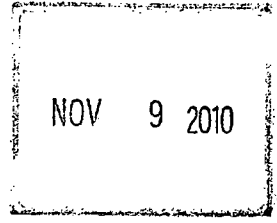

Dear Ms. Even,

The following amendment, submitted in connection with registration under the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), as amended, is acceptable subject to the conditions listed below:

- Addition of use sites and container containment language

**Conditions**

Revise the label as follows:

- 1) Revise the label to provide clarity by deleting the word "only" such that the text on page 1 reads: "For Manufacturing Use".
- 2) Revise the Precautionary Statements to include the following expanded "Wash thoroughly..." statement as per the Label Review Manual. Revise to include: "Wash thoroughly with soap and water after handling and before eating, drinking, chewing gum, *using tobacco or using the toilet.*"
- 3) Revise the Environmental Hazards statement to be in agreement with the ADBAC RED by including the following statement: "This product is toxic to fish, *aquatic invertebrates, oysters, and shrimp.* Do not discharge effluent containing this product into lakes, streams..."
- 4) As per PR Notice 2001-1, reorder the First Aid statements from most toxic to least toxic route of exposure by placing the "If Inhaled" statement immediately following the "If In Eyes" statement.



### First Aid

## STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal.

**PESTICIDE STORAGE:** Open dumping is prohibited. Store only in original container. Do not reuse empty container. Keep this product under locked storage sufficient to make it inaccessible to children or persons unfamiliar with its proper use. Keep from freezing.

**PESTICIDE DISPOSAL:** Pesticide wastes are acutely hazardous. Improper disposal of excess pesticide, spray mixture or rinsate is a violation of federal law. If these wastes cannot be disposed of by use according to label instructions, contact your State Pesticide or Environmental Control Agency, or the Hazardous Waste Representative at the nearest EPA Regional Office for guidance.
