

**PRECAUTIONARY STATEMENTS**  
**DANGER**  
**HAZARDS TO HUMANS & DOMESTIC ANIMALS**  
**KEEP OUT OF REACH OF CHILDREN. CORROSIVE**

**STORAGE AND DISPOSAL**

**1. PROHIBITIONS**  
 Do not contaminate water, food or feed by storage or disposal. Open dumping is prohibited. Do not reuse empty container.

**2. STORAGE INSTRUCTIONS**  
 Store in original container. Keep from freezing.

**3. SPILL OR LEAK PROCEDURES**  
 Small spills may be mopped up, flushed away with water or absorbed on some absorbent material and incinerated. Large spills should be contained; the material then moved into containers and disposed of by approved methods for hazardous wastes.

**4. PESTICIDE DISPOSAL**
