

**PRECAUTIONARY STATEMENTS**  
**DANGER**  
**HAZARDS TO HUMANS & DOMESTIC ANIMALS**

**STORAGE AND DISPOSAL**

**1. PROHIBITIONS**  
 Do not contaminate water, food or feed by storage or disposal. Open dumping is prohibited.  
 Do not reuse empty container.

**2. STORAGE INSTRUCTIONS**  
 Store in original container. Keep from freezing.

**3. SPILL OR LEAK PROCEDURES**  
 Small spills may be mopped up, flushed away with water or absorbed on some absorbent material and incinerated. Large spills should be contained, the material then moved into containers and disposed of by approved methods for hazardous wastes.

**4. PESTICIDE DISPOSAL**
