

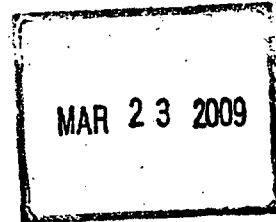

The following amendment, submitted in connection with registration under section 3(c)(7)(B) of the Federal Insecticide, Fungicide, and Rodenticide Act (FIFRA), as amended, is acceptable subject to the conditions listed below:

Addition of New Use

Conditions

1) As per the cited toxicity data and Label Review Manual, revise the precautionary statements to read exactly as follows:

“Corrosive. Causes irreversible eye damage and skin burns. *May be fatal if swallowed or inhaled. Harmful if absorbed through the skin.* Do not get in eyes, on skin, or on clothing. Do not breathe vapor or spray mist. *When handling, wear protective eyewear (goggles or face shield), coveralls worn over long-sleeved shirt and long pants, socks, chemical resistant footwear, chemical resistant gloves and a respirator with an organic vapor removing cartridge with a pre-filter approved for pesticides (MSHA/NIOSH approval number prefix TC-23C), or a canister approved for pesticides (MSHA/NIOSH approval number prefix TC-14G), or a NIOSH approved respirator with an organic vapor (OV) cartridge or canister with any N, R, P or HE pre-filter.* Wash thoroughly with soap water after handling and before eating, drinking, chewing gum, using tobacco or using the toilet. Remove and wash contaminated clothing before reuse.”

- 2) Delete the "Keep Out of Reach of Children" statement from the Precautionary Statements on the left panel. As per the Label Review Manual, this statement is already listed in the appropriate location with the signal word on the right panel.
- 3) Revise the Environmental Hazards statement to begin as follows: "This product is toxic to fish, aquatic invertebrates, oysters, and shrimp. Do not discharge effluent..." This change is required as per the ADBAC RED.
- 4) Revise the Spill and Leak information in the Storage and Disposal section to be in agreement with PR Notice 2000-5: "Small spills *must* be mopped up, flushed away with water or absorbed on some absorbent material and incinerated. Large spills *must* be contained..."
- 5) Revise the Directions for Use section by correcting the following statement: "...water systems, materials preservation for *building materials*: wallboard/drywall and ceiling tiles."



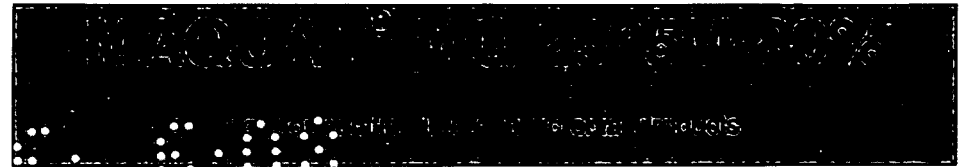

First Aid
